 - a) The person signing the schedule of RATE[S] will be deemed to be the only authorized representative of the bidder for any or all transactions with GMDC in connection with this Tender. His signature will be considered as authorized signature.
 - b) All rates and prices in the tender should be both in figures and in words written in the schedule of Rate(s) Tender(s) containing overwritten or revised rates without being authenticated by bidder signature is/are liable to be rejected. Should there be any variation between the rates indicated in figure and words. The higher of the two shall be considered. Taxes and duties will be extra as applicable.
3. Offer should be accompany earnest money deposit lot wise by demand draft or through RTGS, in favor of GMDC Ltd. Payable at Rajpardi or Bharuch.
