

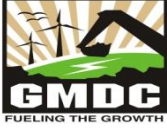

2.0 Preamble

2.1 This tender document is intended to give a general description of nature of the work. It is not intended to cover all minute details. The work shall be executed in accordance with best practices and to the complete satisfaction of the GMDC.

2.2 The information given in this tender document is given in good faith and meant to serve as a guide to enable the prospective bidders to submit their offer. It is, imperative that the Bidder shall obtain and examine, for himself, all the data, information and particulars required for the satisfactory execution of the work covered under the scope of tender.

2.3 The tender document and forms referred to in the tender, if not returned or if returned but not duly filled in (where required) and signed, will result in rejection of the tender.

3.0 Examination

3.1 The Bidder would carefully examine the tender document including all amendments/addendum and corrigendum, if issued, and other details relating to the work and acquaint him fully with all the conditions and matters therein, which may, in any manner, affect the work and the cost thereof.

3.2 The Bidder would obtain all information as to risks, contingencies, responsibilities and other circumstances which might influence or affect his tender, the progress and performance of the contract and to have taken into account all conditions and matters that may affect his works under this tender and cost thereof.

7.0 Bids with joint venture agencies will not be accepted and successful bidder may not assign their work to other third party.

8.0 All applicable taxes and duties etc. towards Supply as well as Erection and commissioning shall be reimbursed as per prevailing rules. TDS will be deducted from the bills as per prescribed rule.

9.0 Validity of the offer: The bidder should agree that the rate submitted shall remain valid for a period of 90 days from the date of the opening of the tender.

1.0 NOTICE INVITATION TO BIDDER:

Gujarat Mineral Development Corporation Ltd. (GMDC) invites bids from reputed financially and technically sound and experienced agency for the “**Supply, Erection and Commissioning of pre fabricated Oil Skimmer Module for the removal of oil and grease from the effluent of vehicle workshop at GMDC Rajpardi Lignite Project, village Rajpardi, Taluka Jhagadia, District Bharuch (Gujarat)**”.

Following is the technical criteria for bidders:

A] Qualification Criteria & Scope:

- a) Bidder must have at least 3 years of experience in waste water treatment construction/fabrication from the last date of bid submission. Bidder must supply 1 oil skimmer along with erection & commissioning. Proof of experience through copies of previous work order or completion certificate for the similar work issued by the present or previous clients.
- b) Annual Turnover of bidder organization during last 3 years [i.e. 2011-12 / 2012-13 & 2013-14 & for the year 2014-15 (If, published)] shall not be less than 10 Lakhs.
- c) Bidder must have facility for waste water monitoring & analysis. Detail of equipment shall be provided along with bid.
- d) Supply, Erection and Commissioning of pre fabricated Oil Skimmer Module for the removal of oil and grease from the effluent of vehicle workshop at GMDC Rajpardi Lignite Project, village Rajpardi, Taluka Jhagadia, District Bharuch (Gujarat) as per followings:
 - i) Bar Screen & Oil water separator skid, Electrical pump and separator vessel, Stainless steel floating skimmer, Suction, discharge and recirculation hose set from sump to feed tank and oil collection tank, 200 L oil collection tank and piping system and Pump starter panel.
 - ii) All the hose pipes for connection of each unit is to be provided by the party.
 - iii) Two coat Epoxy based Primer and two coat Epoxy based paint.
 - iv) Oil Skimmer having 20 Liters per hour oil removal capacity.
 - v) 1 Raw Water Pump of capacity 1 M³/Hour and 1 HP Horizontal Mono block Pump.

- vi) 1 Treated Water Transfer Pump of 1 M³/Hour capacities to transfer treated water from ETP to one vertical 10 KL HDPE Tank.
- vii) UPVC Piping and fittings for transfer as well as with suitable tank/valve connections/fittings etc.
- viii) Wheels to support and carry the module of 2.0 tons from one location to another location through toeing for the treatment purpose.
- ix) Oil Skimmer Details
 - * Oil Skimmer shall be ready to perform continuously for 24 hours and for 365 days in a year.
 - * Suitable Hood Cover shall be provided to protect the mechanism during rainy seasons, because system has to be kept in open
- xi) Treatment plant water must provide Oil & Grease well below 10 PPM in treated water.
- xiv) Control Panel:
 - * Control panel made from 16 G CRCA sheet duly coated with epoxy powder and painted inside as well as outside. Having complete wiring and hinged doors and locking arrangements with proper gasketing.
 - * Having Starter and on - off switches etc.
 - * Suitable HRC Fuse.
 - * Suitable protection relay.
 - * Short circuit protection.
 - * Over voltage and under voltage protection.
 - * KWH Meter.
- xv) Operational and Maintenance Manual along with drawings etc.
- xvi) One year warranty for the oil skimmer module being mentioned above with motor, control panel and all the structures being depicted above in the clauses.
- xvii) On site training for uninterrupted operation and maintenance of the system.

B] General Scope:

a) By GMDC at sites.

- i. Showing the location and their details.
- ii. Raw Water Tank for intake water storage
- iii. Power supply & earthing for the equipment.
- iv. Unloading and internal shifting of equipment module.

b) By bidder:

- i.** Lodging/Boarding etc.
- ii.** Bidder will carry out entire work in a manner to satisfy needs of the GMDC.
- iii.** After commissioning of plant, representative of bidder shall provide the training to GMDC employees for the operation and maintenance of plant.
- ii** Bidder will not sublet the entire work or any part of it to any other agency.
- iii** Bidder will remain in contact with the Officer-In-Charge of Environment at Project and then shall plan their visits in consultation with them.
- iv.** Bidder will abide by statutory regulations applicable at the project e.g. Mines Act, Factory Act and other related Law & Regulations etc.

GMDC reserves the right to terminate this contract at any time without assigning any reason/s. On withdrawal of bidder work order before the contract period by the tenderer, bidder will not make any query or complaint by any mean.

Any dispute shall be resolved mutually. In case of failure, the dispute shall be subject to Jurisdiction of Ahmedabad courts only.

2.0] LOCATION OF THE SITE:

The proposed activity is required for GMDC Rajparadi Lignite Project, village Rajparadi, Taluka Jhagadia, District Bharuch (Gujarat).

3.0 DURATION:

Bidder has to complete the entire work within 3 months from the date of acceptance of this work order.

4.0 TERMS OF PAYMENT:

The payment will be made within 30 days of submission of the invoice/bill after deducting Income tax (TDS) as applicable as per the rules of GMDC. All payments will be made by cheques and/or RTGS only.

5.0 TAXES, DUTIES & LEVIES AND STATUTORY OBLIGATIONS:

All applicable taxes and duties etc. towards Supply as well as Erection and commissioning shall be paid additional as per prevailing rules.

“Service Tax will be paid / adjusted / reimbursed to the successful bidder as per prevailing rates & rules as per Service Tax Act to the extent directly related to the services rendered by the successful bidder under the said contract subject to production of documentary proof and party will mention the service tax amount separately in the invoice / bill after considering the abatement, if any.

TDS will be deducted from the bills as per prescribed rule.

6.0 SUBLETTING OF THE WORK:

Successful Bidder will not sublet the work to any other agency.

7.0 TENDER FEE AND EARNEST MONEY DEPOSIT:

- (a) A non-interest bearing DD of **TENDER Fee of Rs. 500/- (Five Hundred only)** and **Earnest Money Deposit of Rs. 4000/- (Rupees Four Thousand only)** shall be submitted along with desired form provided with tender in separate sealed cover super scribed “**TENDER / EMD Fee**” in favour of GMDC Ltd. payable at Rajpardi from banks approved by Govt. of India from time to time (except co-operative bank) in the form and manner acceptable to the Corporation. Any pending dues against invoice or any other deposit lying with the GMDC will not be adjusted against Earnest Money Deposit. Any Tender submitted without Earnest Money shall be summarily rejected and no claim shall be entertained on such rejected tenders.
- (b) The unsuccessful bidders will be refunded the only EMD amount by way of crossed cheque within 30 days but only after receipt of written request.
- (c) Tender Fee is non refundable and EMD of successful bidder will refund within 3 months after satisfactory completion of contract. Earnest Money will not bear any interest.
- (d) If the party does not accept the work order issued by G.M.D.C., then EMD amount paid by the bidder will be forfeited.

8.0 SECURITY DEPOSIT:

- (a) The successful bidder shall have to deposit Security Deposit @ 5% of the total contract value as per the receipt of the LOI by way of DD in favour of **GMDC Ltd. payable at Rajpardi** from banks approved by Govt. of India from time to time (except co-operative bank) in the form and manner acceptable to the Corporation.

- (b) If the successful bidder does not pay Security Deposit or does not fulfil any of the terms & conditions of this Tender, Earnest Money Deposit paid by such bidder shall be liable to be forfeited by the GMDC.
- (c) Security Deposit paid by the successful bidder shall be liable to be forfeited by the GMDC, if he is not able to maintain the terms & conditions of the Tender.
- (d) Security Deposit paid will be refunded within 3 months after the completion of the work satisfactorily.
- (e) Security Deposit will not bear any interest.

9.0 NO RELAXATION OF EMD/SD.

No relaxation will be made for EMD / SD.

10.0 ACCEPTANCE OF LOI:

If the successful bidder does not accept the Letter of Intent issued by GMDC, the EMD paid by him will be forfeited.

The order will be awarded to the technically and commercially qualified and responsive Successful Bidder, who bid in conformity of the requirement of the specifications of the tender document. A responsive Bid is one which accepts all the terms and conditions of the specifications and tender documents without any major modifications. A major modification is one which affects in anyway the prices, quality, quantity or which limits in any way the responsibilities or liabilities of the Successful Bidder or any right of the Tenderer (GMDC).

11.0 LIQUIDATED DAMAGES:

Successful bidder shall be responsible for “Supply, Erection and Commissioning of pre fabricated Oil Skimmer Module for the removal of oil and grease from the effluent of vehicle workshop at GMDC Rajparadi Lignite Project, village Rajparadi, Taluka Jhagadia, District Bharuch (Gujarat)” as specified / described under the scope of work in this tender and technical document in accordance with sound and established practices, regulations applicable, for the purpose(s) specified, free from defects and suitable for respective uses intended. The cumulative limit of successful bidder’s liabilities under the TENDER, for all guarantees or warranties of whatever nature, whether expressed or implied and all causes whatsoever including

liquidated damages for delay and or non performance shall be limited to 5% of CONTRACT charges / remuneration.

12.0 ACCEPTANCE OF GENERAL TERMS & CONDITIONS:

The bidder should unconditionally accept all the terms and conditions of the contract by signing & stamping on each page of the technical bid document of the tender including the annexure.

13.0 BLACK LISTING OF THE BIDDER:

The Bidder or its directors should not have been black listed by any Government Organization, or any litigation be pending against any of them. The bidder will submit declaration to this effect along with the technical bid. If at any time such declaration is found false, the bid will be rejected or if the contract work is already awarded, it will be terminated forthwith without payment of any compensation and the EMD/SD will be forfeited.

14.0 NON FULLFILMENT OF TERMS & CONDITIONS & TERMINATION OF THE CONTRACT:

If the successful bidder fails to carry out the work as per terms and conditions of the contract to the satisfaction of GMDC, GMDC shall be entitled to terminate the contract and forfeit the EMD / Security Deposit paid by the successful bidder.

If required, for any reason, GMDC reserves right to cancel, terminate, amend and / or alter the contract and / or bifurcate and / or reduce the contract work at any time without giving any notice to the Contractor without incurring any responsibility.

15.0 JURISDICTION:

The Court at Jhagadia in Gujarat State only will have jurisdiction to deal with and decide any legal dispute or contravention between the parties hereto.

16.0 ARBITRATION:

The parties shall endeavour, in the instance, to resolve any dispute, disagreement or difference arising out of or in connection with this Agreement, including any question regarding its interpretation, performance, existence, validity, termination and the rights and liabilities of the Parties to this Agreement (a “Dispute”) through good faith negotiations.

“Matter relating to any dispute or difference arising out of this Tender and subsequent contract shall be subject to the exclusive jurisdiction of Courts at Jhagadia only”.
