TERMS & CONDITIONS

1. Scope of work

The party shall provide the boards & banners as per requirement of Vinyl printing and/or Flex Printing and/or Radium printing at our project and sticking at required place and provide & installation of boards (if required) at different locations at Lignite Project, Tadkeshwar.

2. Quality of work

The quality of printing & material shall be water proof & sun heat proof that the printing shall not fade up to one year. The quality of board provided shall be that they shall not bend or crumble with normal wind or by hand. The sticking shall be done properly by cleaning the board that the banner shall not remove by rain or sun heat.

3. Quantity of work :

Approximate quantity is shown in format of rate quotation. Individual quantity of work may vary as per our requirement.

4. Time Limit and Period

The contract will initially be for a period of one year, which can be extended for a further period of one year on the same terms & condition after satisfactory services and with mutual consent, if required.

5. Rate & Taxes

The party shall quote firm rates, which remain for the entire currency of the contract. Applicable taxes shall be deducted from your bill as per Govt. norms time to time.

6. Earnest money & Security deposit.

- (a) An E.M.D. of Rupee 5000 shall be paid by a crossed /account payee Demand draft in favor of GMDC Limited, Lignite Project, Tadkeshwar along with the tender by the bidders, This will be refunded to unsuccessful bidders without interest, when the contract is finalized.
- (b) Security deposit @ 5 % shall be deducted from each bill which shall not be any interim and shall be refundable to the contractor after satisfactory completion of the contract period. Income Tax shall be deducted from each bill on prevailing rate.

- (c) If the contractor fails to commence the work within stipulated period the management shall terminate the contract & forfeit the EMD and security deposit paid.

7. Delivery of Work

The party shall complete the work as per requirement within stipulated time.

8. Payment of Bill

The contractor shall submit the bills for the work carried out by them during the period (not less than one month) duly certified by the work in – charge. The payments shall be released within 15 days of its receipt after deducting recoveries there from.

9. Statutory Responsibilities & Obligations.

All statutory liabilities shall be borne by the party on their own cost and responsibility.

10. General

- (a) The contractor should visit the site to make him conversant with system & requirement before submitting the tender.
- (b) Tender is required to quote rates strictly as per the terms & condition mentioned above & in these tender documents. Conditional tenders will not be entitled & will be rejected.
- (c) Only the tenders of the tender who are qualified will be considered for further evaluation.
- (d) The Contractor has completed such tipe of work in last two years.

11. Non fulfillment of terms & condition of the contract

If you fail to carry out the work as per terms & conditions of the contract to our entire satisfaction, GMDC shall entitle to for fit the security deposit and E.M.D. paid by you. This however shall not absolve the contractor from your obligation to fulfill the contract. In all such events G.M.D.C. shall have a right to complete and /or to get the work completed at the employer to complete the work and / or to get the work completed at your cost & risk & you shall be responsible to pay such extra cost incurred by G.M.D.C. to complete the work and /or to get the work completed like, wise if you do not fulfill the terms & condition of the contract and do not carry out the work up to the entire satisfaction of GMDC has right to terminate the contract at the sole discretion without assigning any reason what so ever for the same and in each event GMDC shall have right to complete the work and /or to the work completed at your risk and cost.

For any reason if it is required, GMDC reserve the right and / or amend and /or after the contract and /or bifurcate and /or reduce the contract work at any time without giving any notice to you and without incurring any responsibility for such charges.

Any other dispute in this regard shall be settled at (Mandvi) Judicial court.
