INSTRUCTIONS TO THE BIDDER

(To be read & studied before quoting the Tender)

1. All bid documents shall be signed by the authorized person/representative of the bidder.
2. The bidder shall bear all costs associated with the preparation and the submission of the bid. Whether or not, the bid is accepted or even if GMDC withdraws the bid invitation, the bidder shall not be entitled to claim any costs, charges, etc in connection with the bid.
3. It is the bidder's obligation to confirm the scope of the work and work to the best of the efforts to complete the work as per the schedule provided by GMDC.
4. GMDC reserves the right to reject any or all of the bids or accept any of the bids in part or full.
5. The bid shall be evaluated only for the bidders who meet the eligibility criteria.
6. If required the bidders may visit the site along with tender copy, to study the project before submitting the offer.
7. No escalation in price / rate will be allowed on any ground, extension in time limit may be granted with an explicit understanding that no price escalation will be paid.
8. Tenders will be opened in Two Bid system, i.e. Technical Bid and Price Bid. First the Technical Bid will be opened on the date of opening of bid. GMDC will scrutinize the same and the Price Bids will be opened only of those bidders, who are qualifying themselves in Technical Bid.
9. The bidders are required to submit the DD of EMD as per tender notice. It should be noted that if the demand draft of EMD is not submitted, the tender will not be considered for scrutiny and will be summarily rejected.
10. The bidder will have to submit 'NO DEMAND CERTIFICATE' along with the final bill of the work, as per the Proforma given by GMDC.
11. No page from the tender documents shall be defaced or detached. Also no correction in the tender documents shall be made by bidder. Any comments which bidder desires to make, shall not be placed on the tender documents, but shall take the form of a separate statement, as brief as possible, and giving reference to pages and clauses of the tender documents. Submission of tender will be the conclusive evidence that the bidder has fully satisfied himself as to the nature and scope of the work to be done, site conditions, and all other factors affecting the performance of the contract and the price and also as to the terms and conditions of the contract. The tender notice along with the tender documents as detailed together with any other documents as may be hereafter mutually agreed to by the parties, will form the contract agreements referred to above
12. The rates should be written both in figures and in words. In case of any difference between rates in figures and words, the rates in words will prevail.



13. If it is found that two or more persons who are connected with one another either financially or as principal and agent or master and servant have tendered under different names for the same contract without disclosing their connections, then such tenders will be rejected and the earnest money deposit submitted by the bidder shall be forfeited. Any contract entered into under such conditions is also liable to be canceled.
14. In case the bidder is a joint stock company, the contract must be affixed with the seal of the company in the presence of witnesses and signed by two Directors or by persons duly authorized to sign the contract for the company under a power of attorney. The bidder shall produce a certified copy of such power of attorney at the time of making the agreement.
15. Incomplete tenders are liable to be rejected.
16. Other terms and conditions of the tender shall be read and considered as a part of the tender documents.
17. The rates/prices quoted by the bidders will be final and any sort of escalation will not be considered.
18. The mentioned quantities are approximate however the payment will be made on actual quantity as above unit rate on monthly basis. Total price including supply of necessary required spares, consumables, man power, software, etc. as per scope of work mentioned in the tender including all mobilisation / de mobilisation, tool and tackles, manpower, insurance, medical etc. But excluding GST as per rules at actual.
19. Party is requested to visit our project/working site before submitting their offer to review present condition of equipments and all accessories etc. Party is also requested to take plant visit certificate from GMDC official and submit along with the tender. Otherwise GMDC will reject the bid/offer submitted by bidder.
20. If loading unloading is suffering due to non available of sufficient number of weighbridge then penalty @of Rs 500/- per hours (Rs 12,000/- per day) should be applicable to party.

Scope of work:

The Successful bidder has to operate and maintain 3 Nos. weighbridges installed at power project.

- a) The operation and maintenance of complete weighbridge system includes weighbridge cabin , Computers, Printers, UPS and other related all accessories/equipments/spares/plates required for operating of the weighbridge. If required new installation of weighbridge in future instead of existing weighbridge, it will install by Successful bidder at their cost and contract will be considered as BOOM (Built, own, operate and maintain) type without any extra payment. The existing weighbridge scrap/spares will be given to GMDC.
- b) The material like Load cells provided by Successful bidder shall be of reputed/branded make of ISI/CE/NTEP mark only and compatible with existing GMDC software.
- c) Section used in the maintenance of weighbridge platform shall have adequate strength and size.
- d) The Successful bidder shall have to operate and maintain all the weighbridge as in good conditions.
- e) Testing and Stamping from concerned authority will be the responsibility of bidder.
- f) The weighbridges at project shall be calibrated fortnightly and to be certified by GM (Project).
- g) Daily cleaning of the weighbridge including above the platform and underneath the platform is essential & submit the report to GMDC officer incharge.
- h) Successful bidder will have to operate the weighbridges in all three (3) shifts on all working days including off/holidays.
- i) Manpower shall be deployed on 8 hrs. Shift basis.
- j) Shift timings shall be matched with the shift timings of project.
- k) Personnel engaged at weighbridge shall be well acquainted and skilled in its operation so as to carry out the work with effective speed and efficiency. The persons working in Weigh Bridge shall make their attendance in biometric machine, payment shall be made on the basis of attendance certified by person authorized by General Manager(PP).
- l) The Weigh Bridge system should have capacity of 50MT and suitable to Weigh at least 22 and 27 MT net weight capacity of dumper/truck.
- m) Successful bidder will have to make necessary arrangements so as to get minimum 95 % machine output per month.
- n) If loading unloading is suffering due to non available of sufficient number of weighbridge then penalty @of Rs 500/- per hours (Rs 12,000/- per day) should be applicable to party.
- o) Records shall be maintained as desired by GMDC. Record shall be duly signed by Manager/authorized officer in-charge in this regard.
- p) The System & software used for recording the weighment should be compatible to the LAN system & ERP system of GMDC. It should be recorded, maintained and saved in the system format prescribed by GMDC. The daily production and dispatch report should be generated for submission. The compatible software is also in scope of Successful bidder.
- q) The Successful bidder must have a valid license by weights & measurement department. Copy of the same duly attested should be submitted. License from department of metrology, Government of Gujarat for manufacturing / repairing / servicing of electronic lorry weighbridge



in their name. License should be possessed for repairing and servicing for the weigh bridges as per the standards of weight and measure act in the state.

- r) Successful bidder will have to follow all the provisions of Act / labour law Mines Act etc.
- s) The total contract period will be two year.
- t) Successful bidder shall have to supply all tools, tackles, consumables and required spares, soft ware etc. for operation & maintenance of whole system of weighbridges.
- u) The bank account of each weigh bridge personnel would be intimated to project office and payment to each person should need through bank only. Bill will be processed only after the receipt of bank statement. (No cash payments permitted in any circumstances.)

1. SUBMISSION OF BIDS

The bidder shall fill the price schedule in the format given as per attached format online only and the price shall be inclusive of cost of all manpower, consumables, tools and plants, transportation, safety and statutory compliance, mobilization and demobilization etc.

2. Contract Period

Two year (starting from June 2018)

3. INPUTS FROM GMDC-ATPS

Electrical & water supply at one point free of cost. Party shall have to extend further as per their requirement, required lighting arrangements, Electrical power free of cost for operating m/c.

4. TERMS OF PAYMENT

The Successful bidder shall raise the invoice in triplicate addressed to General Manager (Project) after completion of work along with protocol of work executed. The payment of the same shall be made within 30 days thereafter as per the following terms of payment –

- (i) 100% (90% FROM SITE & 10% AFTER APPROVAL FROM HO) payment against the work executed duly certified by GMDC-ATPS E-I-C.
- (ii) GST shall be paid along with bills after fulfillment of following items.
 - Submission of copy of registration certificate issued by GST authority (to be furnished only once).
 - Citing the GST registration no and date of issue of registration certificate on invoices.
 - GST will be paid/adjusted/reimbursed to bidder as per prevailing rates and applicable rules from time to time as per GST Act to the extent directly related to the services rendered by bidder under the said contract subject to



production of documentary proof and bidder will mention the GST amount separately in the invoice/bill after considering the abatement, if any.

- Proof of deposition/adjustment of GST should be provided within three months from the date of RA Bill in respect of related work. In case of non-submission/delay in submission of the proof of deposition/adjustment of GST, GMDC has right to reject the claim as per statutory provision applicable from time to time.
- RA bill must be submitted along with the names of the employee labours employed for the work, attendance sheet, salaries/payment made to them, PF code No., amount of P.F. deducted from the salary made to the labours and employer's contribution amount deposited in RPFC against each and copy of challans for the amount deposited in RPFC office till the previous month duly certified by project office, failing which no payment will be made for the RA bill submitted by the Successful bidder
- TDS or other taxes will be deducted from monthly bill amount as per the prevailing Govt. Rules & regulations.

5. MOBILISATION

Party shall have to mobilise skilled manpower, tools & tackle at ATPS site within 7 days of advance notice. They have to depute one Experience supervisor for co-ordinate with our Engineer-in-charge.

6. SPECIAL/ COMPLSORY INSTRUCTION

- a) **Site Visit Certificate;-** Party is requested to visit our project/working site before submitting their offer to review present condition of equipments and all accessories etc. Party is also requested to take plant visit certificate from GMDC official and submit along with the tender. Otherwise GMDC will reject the bid/offer submitted by bidder

7. OTHER TERMS AND CONDITIONS

- a) All statutory rules and regulations regarding the labour employed by the bidder viz. Insurance, ESI, PF, Minimum Wages, Workmen's compensation act etc. as applicable shall be followed by the bidder. Records of such procedures will be made available to GMDC-ATPS for verification on demand.
- b) All requirements regarding safety of Successful bidder's workmen while on duty at site will be observed by the bidder and bidder will provide all necessary safety or other equipments / services for the same.



- c) Power supply and water connection shall be provided to the Successful bidder at one point. One qualified electrician is to be deputed for electrical work by Successful bidder.
- d) The basis considerations and the essence of the ' Contract' shall be the strict adherence to the time schedule for performing the specified works. The work shall be carried out continuously round the clock.
- e) In case of delay in executing the contract by Successful bidder, GMDC reserves the right to engage another Successful bidder and complete the balance job at the risk and cost of the Successful bidder. Successful bidder should be executed the work as per guided by Engineer In charge.
- f) After mobilization to site immediately start the work Main concern of this contract is time, hence you have to stick on to the time schedule as indicated above.
- g) Third party liability and Transits insurance of the consignment/ Insurance of Successful bidder's manpower are to be provided by the Successful bidder at his cost.

8. **Penalty;-** If loading unloading is suffering due to non available of sufficient number of weighbridge then penalty @of Rs 500/- per hours (Rs 12,000/- per day) should be applicable to party.

9. LIQUIDATED DAMAGES:

In case the contractual work is not completed within time prescribed limit and the reason is not attributable to GMDC, Liquidated Damage @1% of total contact value per week subject to maximum of 10 % of total contact vale shall be levied. GMDC shall be at a liberty to recover the amount of liquidated damage from the invoice and/or security deposit submitted by Successful bidder

STATUTORY COMPLIANCE OF LABOUR LAWS

Statutory compliance of the labour laws on the part of Successful bidder is as under:

1. The Successful bidder shall at his own cost comply with the provision of labour laws, rules, orders and notifications whether central or state or local as applicable to him or to his contract from time to time. These Acts/Rules include without limitation of the following.
2. Successful bidder shall be solely responsible and shall fully comply with all the provisions of all the labour laws, applicable such as Minimum Wages Act, 1948, Payment of Bonus Act 1965, Employees Provident Fund and Miscellaneous Provision Act 1952, Industrial Dispute Act 1947, Workmen Compensation Act 1923, Payment of Gratuity 1972, Interstate Migrant Workmen Act 1979, Equal Remuneration Act with Rules, Order and Notifications issued/made there under from time to time.
3. All other Acts, Rules/Byelaws, Orders, Notifications etc. present or future applicable to the Successful bidder from time to time for performing the contract job.
 - 3.1 The Successful bidder shall provide and be responsible for payment of Wages, salaries, Bonus, Social charges, Insurance, Food, Accommodation, Transport, Medical and Canteen facilities and other statutory privileges and facilities to his personnel per law/rules/regulations and orders of the Central Government, State government, Local authorities or other authorities as are in force from time to time. All employees of the Successful bidder shall be employee of the Successful bidder.
 - 3.2 The Successful bidder shall have a valid license obtained from Licensing Authority under the Contract Labour (Regulation & Abolition) Act 1970 at the time of execution of the contract covering all his employees working at ATPS site and furnish the same, failing which GMDC may terminate the contract at its sole discretion.
 - 3.3 The Successful bidder shall at the time of execution of the contract have an EPF code number obtained from the Authorities concerned under the Employees Provident & Miscellaneous Provisions At, 1972 and remit contributions in respect of the employees employed by him at ATPS site to the PF office concerned every month, failing which GMDC will recover from the outstanding payment to the Successful bidder from GMDC.
 - 3.4 The Successful bidder shall maintain all records/registers required to be maintained by him under various Labour Laws mentioned above and produce the same before the Statutory Authorities whenever required.
 - 3.5 The Successful bidder shall also submit periodical reports/returns to the various statutory authorities such as the Contract Labour (Regulation and Abolition) Act, 1970, Employees Provident Act etc. under intimation to P&A Dep't.
 - 3.6 The Successful bidder shall not pay less than the Minimum Wages notified by the Government from time to time to his employees of corresponding categories.
 - 3.7 The Successful bidder shall be responsible for payment of overtime Wage to his workmen, if any, in case they are required to work beyond the prescribed hours under law as per applicable rates.
 - 3.8 The Successful bidder shall take Workmen Compensation Insurance Policy for all his employees working at ATPS. The Successful bidder shall indemnify the company against any liability due to any work injury or accident to any of its employees.
 - 3.9 The Successful bidder shall in the event any of his workmen/employees sustains any injury or disablement due to an accident arising out of and in the course of his employment, provide necessary medical treatment and pay compensation s applicable, required under the Workmen's Compensation Act, 1923.



- 3.10 If any of the persons engaged by the Successful bidder misbehave with any of the officials or the Company or commit any misconduct with regard to the property of the Company or suffer from any serious communicable disease, the Successful bidder shall replace them immediately.
- 3.11 The Successful bidder shall not engage/employ persons below the age of 18 years. Employment of women shall be strictly according to applicable laws.
- 3.12 GMDC will have right to deduct and disburse the claims of the individual/parties being a principal employer on any account whatsoever in relation to their employment with the Successful bidder. The security deposit will be released to the Successful bidder at the end of the contractual tenure subject to an undertaking by the Successful bidder that in the event any of his workmen or the heirs of workmen puts a claim or recovery of money due to him from the Successful bidder before the appropriate authority under the I.D Act 1947 or under any other labour laws or for compensation under the Workmen's Compensation Act, 1923 and the appropriate authority has given a direction for making payment the Successful bidder will meet the same or indemnify GMDC if in the event GMDC pays it as Principal Employer.
- 3.13 The Successful bidder shall make payment of wages to his employees on fixed date within the period specified under the applicable Laws, in presence of representative of the Company. He will submit a true copy of wages sheet, attendance register and PF remitted challans on monthly basis to P&A dept. for verification and record.
- 3.14 The Successful bidder shall provide Safety items/kits to his employees such as safety shoes, goggles, ear plug, hand gloves, safety belts etc, if any, required under the law.
- 3.15 The Successful bidder shall conduct pre-induction and periodic medical checkup of his workmen as per applicable laws.

This list is indicative in nature and not an exhaustive one. Any amendment/alteration/Notifications or addition to the existing law or a new statute shall automatically become applicable.

OTHER TERMS & CONDITIONS OF TENDER NO. GMDC/HO/PD/ATPS/13/17-181)

1) Security Deposit:

The successful bidder shall have to deposit Security Deposit by way of Demand Draft / Pay Order/BG at 10% of the order value (including EMD) within a 7 days after receipt of the LOI.

If the Successful bidder does not pay Security Deposit or does not work as per our order or does not fulfill any of the terms & conditions of this tender, Earnest Money deposit paid by such Successful bidder shall be liable to be forfeited by the Corporation.

Security deposit paid by the successful bidder shall be liable to be forfeited by the Corporation, if he is not able to do work in accordance with the terms & conditions.

Security Deposit paid will be refunded within 90 days after the execution of the work satisfactorily.

Earnest Money / Security Deposit will not be bearing any interest.

2) No Relaxation on EMD / SD:

Unit registered with Govt. of Gujarat / National Small Industrial Corporation Ltd As SSI Unit will not be exempted from paying Earnest Money Deposit / Security Deposit in any case. Cheque will not be accepted.

3) Validity:

Rate quoted shall remain valid for 180 days from the date of opening of the Technical-Bid,

4) Order will be issued to the successful bidder and in any case request for changing bidder name will not be considered.

5) The tender submitted in contravention of the terms & conditions stated herein will not be considered.

6) No conditional tender will be accepted and will be rejected outright.

7) For any typographical error in this tender, decision taken by Corporation will be final & binding to all the bidders.

8) In case of disputes or difference of opinion in the interpretation of any of the terms & conditions of this tender, the decision of the G.M(POWEWR), of GMDC shall be final and binding to all.

9) The Corporation reserves the right to reject any or all tenders without assigning any reasons thereof. The Corporation also reserves the right to amend, alter, increase or decrease the quantity of the work. If necessary to do so the Corporation reserves right to terminate this contract, without assigning any reasons thereof to the Successful bidder. For any of the above act, the corporation does not accept any liability or any financial or other loss that the Successful bidder may have to suffer in exercising this power by the Corporation.

10) The Court at Ahmedabad in Gujarat State only will have jurisdiction to deal with and decide any legal



dispute or contravention between the parties hereto.

- 11) Bidders are advised to visit the site to study the actual working conditions, before submitting their offer and no excuse in this regard in case of any lapse or fault shall be acceptable later.

Any neglect or failure on the part of the bidder in obtaining necessary and reliable information on the foregoing or any other matters affecting the contract shall not absolve him from any risks or liabilities or the entire responsibility from completion of the works at the scheduled rates and time, in strict accordance with the contract documents.

- 12) GMDC will not be responsible for any postal delay whatsoever.
- 13) Bids once submitted shall not be returned and shall remain the property of GMDC.
- 14) The quantity mentioned in the tender (price schedule) is approximate however the payment will be made on actual quantity is to be weighted on monthly basis. The proof of quantity weighted should be submitted to the engineer in-charge and it will be certified by GMDC officer/department head/ project head.
- 15) At any time GMDC shall fore close the contract with giving an advance notice of two months. The bidder shall have to clear the premises/space at once and leave the site without any extra cost or burden on GMDC.
- 16) GMDC may terminate the contract after due recoveries of pending jobs/damages after giving 30 days notice to the bidder on the occurrence of the following events.
 1. Successful bidder is adjudged as insolvent.
 2. Successful bidder is abandoned the contract.
 3. Successful bidder fails to proceed with the work with due diligence as per the requirements of the work order.

If at any time during the currency of this contract, if any breach occurs due to the fault of Successful bidder, GMDC shall be at liberty to terminate this contract without assigning any reasons, whatsoever, for such termination and any losses and/or damages occurring due to such termination shall be borne by Successful bidder.

TERMINATION OF THE CONTRACT.

- 1 If the Successful bidder fails to carry out the work as per terms and conditions of the contract to the satisfaction of the CORPORATION, CORPORATION shall be entitled to forfeit the security deposit paid by the Successful bidder. This however, shall not absolve the Successful bidder from his obligation to fulfill the contract. In such event, the CORPORATION shall have a right to complete and / or to get the work completed at the cost & risk of the Successful bidder and the Successful bidder shall be responsible to pay such cost incurred by the CORPORATION to complete the work and / or to get the work completed.

- 3 For any reasons, if it is required, the CORPORATION reserves rights to cancel terminate amend and / or alter the contract and / or bifurcate and / or reduce the contract work at any time without giving any notice to the Successful bidder and without incurring any responsibility. For such cases, Successful bidder shall have to take away his labour, tools, tackles, machinery, equipment etc. and shall leave the site at once or shall have to carry out the instructions of the CORPORATION.

ARBITRATION:

The parties shall endeavor, in the first instance, to resolve any dispute, disagreement or difference arising out of or in connection with this agreement, including any question regarding its interpretation, performance, existence, validity, termination and the rights and the liabilities of the parties to this agreement (a 'dispute') through good faith negotiation.

“All questions, disputed, differences and /or interpretation of tender/LOI/Work order/agreement whatsoever, which may at any time arise between the parties to this contract in connection with the contract or any matter arising out of or in relation there to, shall be refer to Sole Arbitrator as per the provision of Arbitration and Reconciliation Act., 1996. The venue of arbitration proceedings shall be at Ahmedabad. The language of Arbitration shall be in English.”

JURISDICTION:

“Matter relating to any dispute or difference arising out of this tender and subsequent contract shall be subject to the exclusive jurisdiction of courts at Ahmedabad only.”



Force Majeure

Force majeure is herein defined as any cause which is beyond the control of the Successful bidder or the Corporation as the case may be which they could not foresee or with reasonable amount of diligence could not have foreseen and which substantially affect the performance of the contract, such as:

- (i) Natural phenomena such as flood, draughts Cyclone, earthquake and epidemics, declaration of war.
 - (ii) Acts of any government, including but not limited to war, declared or undeclared priorities, quantities, embargoes, providing either party shall within fifteen (15) days from the occurrence of, such a cause notify the other in writing of such cases
- a. Your company will advise, in the event of his having resort to this clause by a registered letter duly certified by the statutory authorities, the beginning and end of the cause of delay, within fifteen days of the occurrence and cessation of such Force Majeure condition. In the event of delay lasting over two months, if arising out of Force Majeure, the contract may be terminated at the discretion of the Corporation.
- b. For delay arising out of Force Majeure, your company will not claim extension in completion date for a period exceeding the period of delay attributable to the causes of force Majeure and neither company nor the Successful bidder shall be liable to pay extra costs (like increase in rates, remobilization, advance, idle charges for labour and machinery etc.) Provided it is mutually established that the Force Majeure conditions did actually exist.
- c. The Successful bidder or the Corporation shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/ or defined above. The date of completion will, subject to hereinafter provided, be extended by a reasonable time given though such cause may occur after Successful bidder's performance of his obligations has been delayed for other causes.
