

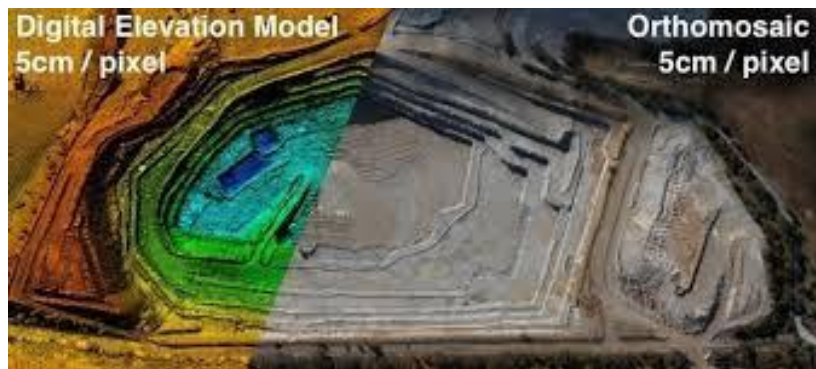

## DEFINITIONS

In this RFP, the following word (s), unless repugnant to the context or meaning thereof, shall have the meaning(s) assigned to them herein below:

1. **“GMDC”/Authority** shall mean the Gujarat Mineral Development Corporation Ltd who shall appoint the Contractor for the captioned work.
2. **“Bidder”** shall mean any firm or body corporate which is a Limited Liability Partnership registered under LLP act or a company under the Indian Companies Act 1956/2013 which submits a Bid to provide Services to GMDC along with Bid Security and RFP Fees as per the terms of this RFP within the stipulated time for submission of Bids.
3. **Bid/Proposal** means the Bid submitted by the Bidder(s) in response to this RFP in accordance with the provisions hereof including Technical Bid and Price Bid along with all other documents forming part and in support thereof as specified in this RFP.
4. **“Bid Due Date”** means last date of Bid submission as set out in clause 2.6 of SECTION III
5. **“Agency/Contractor”** shall means the successful bidder /bidders who has/have deposited the necessary Earnest money and has/have been given written intimation about the acceptance of RFP and shall include legal representative of such individual or persons composing a firm or a company or the successors and permitted assignees of such individual, firm or Company, as the case may be and any constitutional, or otherwise change of which shall have prior approval of the employer.
6. **“Contract Agreement/Agreement/Contract”** is the agreement entered into between ‘Gujarat Mineral Development Corporation Ltd (GMDC)’ and ‘Contractor’ comprising of all terms and conditions stated in this RFP.
7. **“Consortium”** shall mean the group of legally constituted entities, who have come together to participate in captioned work.
8. **“Corrupt practice”** shall have the meaning ascribed thereto under clause 10 of SECTION III.
9. **“Conflict of Interest”** shall have a meaning specified in clause 11 of SECTION III.
10. **“Contract Fees /Fees/Service Charges”** shall mean the charges payable by GMDC for the work/services rendered by the Contractor.
11. **“Pre-Qualification Criteria”** means criteria specified in clause 6.1 of SECTION III
12. **“Evaluation Process”** means steps of evaluation specified in clause 8 of SECTION III
13. **“EMD/ Bid Security”** means the Bid security/ earnest money deposit to be submitted by the Bidder as per clause 3.5 of SECTION III.

**14. Letter of Award**” shall have the meaning ascribed thereto under clause 9.1of RFP SECTION III.

**15. “Parties”** means the parties to the Contract Agreement and “Party” means either of them, as the context may admit or require.

**16. “Preferred Bidder “**shall have a meaning specified in clause 9.3 (iv) of RFP SECTION III.

**17. “Successful Bidder”** means the Preferred Bidder selected in terms hereof and to whom GMDC shall issue the Letter of Award in accordance with the provisions hereof and who shall undertake the Terms of Reference as per the terms specified in RFP.

**18. “Terms of Reference/Scope of Work”** means all the activities as per Terms of reference or Scope of work mentioned in the RFP which the successful bidder is required to carry out as per the Good Industry Practice. Detailed Terms of Reference is specified in SECTION II of RFP.

**19. “Third Party”** means any Person other than GMDC and the Contractor.

Any other term(s), not defined herein above but defined elsewhere in this RFP shall have the meaning(s) ascribed to such term(s) therein and shall be deemed to have been included in this Section.

## SECTION I: BACKGROUND

Gujarat Mineral Development Corporation Ltd (GMDC) is the leading State-owned Mining and Minerals Company of Gujarat with operational experience over 50 years and having product portfolio across mining, value added products and power.

GMDC is a zero-debt company listed on National and Bombay Stock Exchanges. The Government of Gujarat (GoG) disinvested 26% stake to the public shareholders vide an IPO in 1997 while the balance ownership is held by the Government of Gujarat. It stands fifth in terms of market capitalization (Rs 2100 crore/ USD 300 m) among its peers as on July 2021.

GMDC's mining activities are spread across the state of Gujarat in Kutch, Devbhoomi Dwarka, Panchmahal, Bhavnagar, Bharuch, Surat and ChhotaUdepur districts. It currently mines Lignite, Bauxite, Manganese, Ball Clay, Silica Sand, Bentonitic Clay and Limestone. It has five (5) operational lignite mines and six (6) upcoming lignite mines. GMDC also value adds to minerals through works such as pyrite removal from lignite, beneficiation of bauxite, and beneficiation of Low-Grade Manganese. The Company has set up 2 x 125 MW lignite based Thermal Power Station at Nani Chher in Kutch as a forward integration, wind power plant of 200.9 MW at Maliya, Jodiya, Godsar, Bhanvad, Bada, Verbala, Rojmal and Solar Power plant of 5 MW at Panandhro Project.

GMDC is also on process of obtaining lease for six new lignite blocks in various district of Gujarat State. All new proposed project sites are in Gujarat in Bharuch, Surat and Kutch Districts with a block area of 1000 to 5000 hact.

GMDC would like to have an end to end solution to survey, monitor and manage its various working and upcoming mines spread across the state of Gujarat.

GMDC requires appointing the renowned professional agency for drone surveying for digital aerial images and mapping of existing mines i.e. lignite and not lignite mines as well as new lignite blocks as per the Government of India notification No. G.S.R. 780 (E) dated 03<sup>rd</sup> November 2021 issued by Ministry of Mines ( say here "Notification"). Agency shall conduct drone survey, process the data , generate analysis reports , generate output in prescribed standard format as may be specified by the Indian Bureau of Mines as well as to the satisfaction of GMDC and populate the drone data through computerize synchronization. **This drone survey is for existing working mines lease area and new lignite bocks area and up to 100 meters outside the lease boundary.**

## SECTION II: TERMS OF REFERENCE/SCOPE OF WORK

The detailed Terms of Reference, Deliverables and Timeline are specified in this section.

### 1. SCOPE OF WORK

The qualified agency / agencies / contractor have to carry out a drone survey of the all mining leased areas (Table – A) and up to 100 meters outside the lease boundary between 1<sup>st</sup> April and 15<sup>th</sup> May every year ( except first year ) and as per the clause no. 34A (5) of MCDR ( Amendment) 2021 and have to submit the processed outputs (Digital elevation model (DEM) and orthomosaic images ) obtained from such survey or any other format as may be specified by Indian Bureau of mines in this regard to the controller General on or before 1 day of July every year.

**The qualified agency / agencies / contractor should carry out drone survey and images processing work and output related work as per the Standard operating procedure declared by the Indian Bureau of mines or any other competent agency including Ministry of coal or its subsidiary from time to time.**

The Clause 34A (5) of MCDR (Amendment) 2021, which read as under.

***“The standard operating procedure for carrying out the drone survey and form of the data to be submitted shall be specified by the Indian Bureau of Mines from time to time.”***

**Broadly, the agency would need to provide the following services:**

- (a) Provision of Ground controls as per requirements of project to achieve the required accuracy.
- (b) Procuring necessary clearances from DGCA & Ministry of Defense, Government of India, and other agencies for flying over the AOI to acquire raw LiDAR data, Imagery etc.
- (c) Compliance of Requirements for Operation of Civil Remotely Piloted Aircraft System (RPAS) issued by DGCA and amendment issued to it time to time.

OR

- (d) Compliance of requirements for operation as non scheduled operator for performing aerial survey work issued by DGCA/MOCA. Compliance of latest Aircraft rules and amendments issued to it time to time.
- (e) Preparation of flight plan
- (f) Acquiring and pre-processing LiDAR data and integration of Geoid model for obtaining orthometric heights for each point
- (g) Post-processing of LiDAR data to fulfill the requirement of Ministry of Mines or Ministry of Coal or any other competent authority.

- (h) Block adjustment and ortho rectification
- (i) Conducting Quality Control/Quality Assurance (QC/QA) to establish correctness of flight operations
- (j) Validating horizontal and vertical accuracy through independent means
- (k) Compliance with other product requirements such as file naming, datum and projection, units, etc
- (l) Delivery of raw data, other products and supporting reports

The SOW is broadly divided into three parts as mentioned below.

- Part 1: Pre- Requisites
- Part 2: Drone operation for Data Acquisition
- Part 3: Data processing and Analysis

Detailed activity under each of above part is specified below.

#### **Part 1: Pre-Requisites**

- a) The agency shall ensure that the necessary permissions and clearances for drone operations are obtained from respective authorities wherever applicable such as, including, but not restricted to the following:
  - i. Directorate General of Civil Aviation (DGCA)
  - ii. Ministry of Defense (MoD)
  - iii. Ministry of Home Affairs (MHA)
  - iv. Air Traffic Control (ATC)
  - v. Local Police and District Administration etc.
- b) The above clearances, and permissions shall have to be mandatorily obtained prior to commencement of the flight operation and the agency shall have to also mandatorily submit a copy of the permissions and clearances received, to GMDC.
- c) It shall be the responsibility of the agency to ensure that the drone operations do not take place without obtaining the relevant permissions from respective authorities.
- d) The agency shall be responsible for engaging required manpower to complete the work within the specified period.
- e) Prior to commencement of flight operation, the agency shall conduct necessary field visits for the study of the area for flight planning and establish Ground Control Points (GCPs), if required. (Agency shall establish GCPs depending on the requirement to meet the desired specifications of the deliverables)
- f) Agency shall ensure that accuracy of the Differential GCPs shall be less than 3 cm. The GCPs should be clearly visible on drone images.

#### **Part 2: Drone operation for Data Acquisition**

Agency shall deploy required number of drones at multiple mining sites i.e., either fixed wing or multi-rotor Drones with mini or micro weight class, as per DGCA's latest regulations for data acquisition, few parameters of which are illustrated, (non-exhaustive) below

- Certified Mine Surveyor Certificate from DGMS (with proof of employment)
  - Drone Pilot Certificates/ Licenses
  - DGCA Approved Survey grade Drone etc.
  - Every flight should be recorded in the digital sky platform
- a) Agency shall ensure that base station is established for each Drone flight.
  - b) Agency shall ensure that endurance of each Drone for data acquisition shall not be less than 30 minutes.
  - c) Agency shall perform the data acquisition through **normal** flight, **cross** flight as well as **perpendicular** flight so that no object is missed while collecting the data, if required.
  - d) Agency shall ensure that the communication range of each Drone shall not be less than 3 km radius.

The recommended minimum overlap shall be:

- i. 75% frontal and 60% side overlap in general cases.
- ii. 85% frontal and 70% side overlap for forests, dense vegetation and fields.
- iii. 85% frontal overlap for single track corridor mapping.
- iv. 60% side overlap if the corridor is acquired using two flight lines.

### **Part 3: Data Processing and Analysis**

- a) The Agency shall deploy required number of resources on project to process the data and generate required outputs within the shortest possible time, as the outputs are expected on real-time or near real-time.
- b) The data processing and its analysis shall have to be carried out in a manner to maintain the confidentiality of the data. No data shall be shared to any third party without prior written approval from GMDC.
- c) The Agency shall ensure that all flight data be brought into a single block and it shall be in the desired correction range.
- d) The Agency shall generate Digital Terrain Model (DTM), Orthmosaic and if require contours from those mining blocks under survey.
- e) The acquired drone images shall be adjusted together with a bundle adjustment process along with the image matching process and point cloud generation. The accuracy report of such adjustment shall be submitted with respect to the established ground control points.

- f) The accuracy of derived DTM shall be verified against the identified GCPs for its vertical accuracy.
- g) The orthomosaic shall be generated after achieving the vertical accuracy of DTM and the image adjustment report. The orthomosaic shall be seamless and colour balanced with no artifacts. (Nadir/near nadir images to generate orthomosaic are preferred)
- h) Unwanted features like water, glass etc. shall be removed from Point cloud.
- i) The boundaries of each mining blocks shall be clearly visible on the processed data.
- j) The Agency shall process the data and submit the deliverables as per the work plan mentioned in technical proposal.
- k) The Agency shall generate the volumetric and extent analysis reports for each and every mining site (as listed in Annexure 12) in GMDC and ensure that accuracy to be achieved is at 100%.
- l) GMDC may engage separate Audit team to carry out the checks pertaining to accuracy/correctness/completeness of Bidder's data/processed output such as point cloud, orthomosaic, DSM, DTM, contours and 3D model.
- m) GMDC may deploy a Government agency/private agency at its discretion to audit or countercheck the data furnished by the Agency. Such audits may happen on a bi-annual or annual basis and the Agency shall provide the required data and support to facilitate the same.
- n) The Agency shall address the audit observation by rectifying its data and output as deemed necessary.
- o) Quality Control / Quality Assurance

Quality Control/ quality Assurance (QC/QA) of the LIDAR and/or LiDAR derived data at various stages of mines including validating horizontal and vertical accuracy as per specifications laid down in RFP will be the responsibility of the agency. GMDC may perform additional QC/QA testing. This shall include (a) carrying out corrections as per quality Audit Report and security vetting report provided by GMDC (b) Facilitating per quality audit, stage approvals , security vetting and final acceptance tests by GMDC (c) carrying out corrections after security vetting as pointed out by concerned agencies

## 2. DELIVERABLES

This section should be read in relation to the above scope of work and not in isolation. The bidder shall submit the deliverables along with file structure, metadata, processing and analysis reports. The deliverables include all the Digital Terrain Model (DTM), orthomosaic

images and contours as per the requirement of notification and these reports in the standard such as GeoTIFF format along with metadata or any other format as may be specified by the Indian Bureau of Mines or Ministry of Coal or any other competent agencies.

The agency have to submit Four colour hard copies & soft copies in pen drive for required out puts as per IBM / MoC / any other competent agencies's requirement of each mining lease / Block area during the period of contract.

The agency has also help GMDC for Geo – referencing of any present or upcoming structures within the lease area or part thereof as & when required during period of contract.

The agency has also help GMDC for preparation of KMZ file or any other file type compatible with our Geological or mining software for any lease area or part thereof as & when required during period of contract.

**The all deliverables shall be submitted within 15 days of completion of drone survey of each working mine / block in the format / SOP as may be specified by the Indian Bureau of Mines or Ministry of Coal/Mines from time to time.**

#### **B. Data acquisition**

The following data shall be submitted as part of data acquisition:

- a) Drone class type, make & model details, drone registration number of all deployed drones.
- b) Sensor calibration details/report
- c) Make and Model of Inertial Navigation System (INS), GPS receiver details of base as well as for RTK/PPK mode receiver on drones
- d) Raw images in jpeg/tiff format in standard storage device
- e) Ensure that images should not have seam lines, blur, cloud and haze but should have perfect colour balancing
- f) Organization of the delivered data such as file name, folder structure.
- g) Flight details such as flight path including time, position, image start and end number for each flight and orientation parameters for each observation(s).
- h) The base station co-ordinates or the control point number on which each base is operated.

## Acceptance of Deliverables

The Agency shall submit the above deliverables with desired specifications and meet the following parameters of accuracy/data quality standards.

These have to be accepted and approved by GMDC.

- i. Vertical accuracy of DEM should be better than 10 cm with respect to GCP.
- ii. Contour Interval should be 10 cm. Every 1 m contour should be indexed.
- iii. Absolute Positional accuracy of ortho should be better than 10 cm with respect to GCP
- iv. Relative positional accuracy of ortho should be better than 2 pixels.
- v. Point cloud shall be carried out using area and distance measurement from GCPs
- vi. 3D model shall be generated using high point cloud density if required.

It is the responsibility of the successful bidder to ensure that they will submit all the final data, reports, images etc. to GMDC in the formats as per the latest Standard Operating Procedure specified/published by IBM or MoC – New Delhi or any other competent agencies as well as submission to concerned statutory authority for which no separate or extra payment will be made by GMDC.

## E. Schedule of Drone Survey

Except first year drone surveys shall be conducted for all mines of Group – 1 as mentioned at annexure – 12 for a period of three years from 1<sup>st</sup> April to 15<sup>th</sup> May, and for all other mines and new lignite blocks of Group -2 for one year only.

**The all deliverables shall be submitted within 15 days of completion of drone survey** of each working mine/block in the format / SOP as may be specified by the Indian Bureau of Mines or Ministry of Coal/Mines from time to time.

## SECTION III: INSTRUCTIONS TO BIDDERS

### 1. ELIGIBLE BIDDERS

#### 1.1. BIDDERS ELIGIBILITY

The Invitation for Bid is open to all Bidders including an individual, proprietorship firm, partnership firm, company registered under Companies Act, any legal entity or joint ventures. The bidders shall be eligible to participate only if they fulfill the qualifying/eligibility criteria specified in RFP.

#### 1.2. BIDDER'S DIGITAL SIGNATURE

The bidders shall have Digital Signature Certificate (DSC) issued from any agency authorized by Controller of Certifying Authority (CCA), Govt. of India and which can be traced up to the chain of trust to the Root certificate of CCA.

#### 1.3. Joint Venture/Consortium Details

Two or three companies/contractors may jointly undertake contract/contracts. Each entity will be jointly and severally responsible for completing the task as per the contract.

Name of all the partners of a Joint Venture/ Consortium (not more than 3):

- a. Lead Partner
- b. Partner
- c. Partner.

Joint Venture (JV)/Consortium must comply the following requirements:

- (i) Following are the minimum qualification requirements for a joint venture.
  - a. The minimum qualification requirements for Joint Venture: The qualifying criteria parameters e.g. experience, financial resources etc. of the individual partners of the JV will be as deliberated under clause 8 of section III of the RFP towards fulfillment of qualification criteria related to the experience.
  - b. The qualifying criteria parameter e.g. financial resources (Working Capital/turnover) of the individual partners of the JV will be added together, for the relevant period, and the total criteria should not be less than as

deliberated under Clause No. 8 of section III of the RFP towards fulfillment of qualification criteria related to Working Capital/financial turn over.

- (ii) The formation of Joint Venture or change in the Joint Venture character/partners after submission of the bid and/or any change in the bidding regarding Joint Venture will not be permitted.
- (iii) The bid, and in case of a successful bid, the agreement shall be signed, so as to legally bind all partners jointly and severally and bid shall be submitted with a copy of the Joint Venture Agreement providing the joint and several liabilities with respect to the contract.
- (iv) The pre-qualification of a joint venture does not necessarily pre-qualify any of its partners individually or as a partner in any other joint venture or association. In case of dissolution of a joint venture, each one of the constituent firms may pre-qualify if they meet all the pre-qualification requirements, subject to written approval of the employer.
- (v) The JV Agreement must include the relationship between joint venture partners in the form of JV /Consortium agreement to legally bind all partners jointly and severally for the proposed agreement which should set out the principles for the constitution, operation, responsibilities regarding work and financial arrangements, participation (percentage share in the total) and liabilities (joint and severally) in respect of each and all of the firms in the joint venture. Such JV Agreement must evidence the commitment of the parties to bid for the facilities applied for (if pre-qualified) and to execute the contract for the facilities if their bid is successful.
- (vi) One of the partners shall be nominated for being in charge of the contract and shall be designated as Lead Partner. This authorization shall be evidenced by a Power of Attorney signed by legally authorized signatories of all the partners at the time of bidding.
- (vii) The JV / Consortium agreement must provide that the Lead Partner shall be authorized to incur liabilities and receive instructions for and on behalf of any and all partners of the Joint Venture and the entire execution of the contract shall be done with active participation of the Lead Partner.
- (viii) The contract agreement should be signed jointly by each Joint Venture Partners. Subsequent declaration/ letters/ documents shall be signed by the lead partner authorized to sign on behalf of the Joint Venture or by the authorized signatory on behalf of the JV.

- (ix) The bid should be signed by all the partners of the Joint Venture.
  - (x) An entity can be a partner in only one Joint Venture. Bid submitted by Joint Ventures including the same entity as partner will be rejected.
  - (xi) The JV /Consortium agreement may specify the share of each individual partner for the purpose of execution of this contract. This is required to fulfill eligibility and also for the purpose of apportioning the value of the contract to that extent to individual partner for subsequent submission in other bids if he intends to do so for the purpose of the qualification in the bid.
  - (xii) The earnest money/ Bid security/ Bank guarantee can be submitted by the JV/ Consortium or one or more partners of the JV / Consortium.
  - (xiii) The JV /Consortium agreement must be specific that it is valid for the project for which the bidding is done. If the JV /Consortium breaks up midway before award of work/ during bid validity period the bid will be rejected. If the JV breaks up midway before award of work/during bid validity/after award of work/ during pendency of the contract; in addition to normal penalties as per provisions of the bid document, all the partners of the JV /Consortium shall be debarred from participating in future bids for a minimum period of 12 months in GMDC.
  - (xiv) JV /Consortium agreement shall be registered in accordance with the law so as to become legally valid and binding on the members before making any payment.
  - (xv) JV /Consortium shall open a bank account in the name of the JV and all payments due to the JV shall be credited by the employer in that account only. To facilitate statutory deductions all statutory documents like PAN/TIN etc. shall be submitted by the JV before execution of the agreement for the work/ before making any payment.
- Note:** In case the work/service is awarded to a Joint Venture participating in the RFP they have to submit PAN and GST registration (as applicable in the RFP and for the bidder status) on the name of the Joint Venture after Award of Work/Service at the time of execution of agreement/ before the payment of first running on account bill.
- (xvi) The bidders have to accept unconditionally the online user portal agreement which contains the acceptance of all the Terms and Conditions of RFP, including General and Special Terms & Conditions, technical specifications, other conditions, if any, along with on-line undertaking in support of the authenticity of the declarations regarding the facts, figures, information and documents furnished by the bidder on-line in order to become an eligible bidder.

- (xvii) No sub-letting of the work as a whole by the contractor is permissible. Prior permission is required to be taken from the principle employer for engagement of sub-contractors in part work/piece rated work.

## 2. BIDDING PROCEDURE

### 2.1. Bidding Process

- a. GMDC has adopted a single stage two packet online bidding system separately for Technical Bid and Price Bid with evaluation as per Method as detailed out in **RFP for Procurement of Services for Drone Surveying and mapping of existing and upcoming mining projects** (the “**Bidding Process**”). Technical Bid shall be submitted physically whereas Price Bid shall be submitted online through <https://gmdc.nprocure.com>. The Bids for which the Price Bid is submitted in hard copy / physical form shall be rejected as non-responsive. Complete Bid shall be submitted on or before the time and date fixed for submission of Bid (“**Bid Due Date**”). Bid delivered after Bid Due Date will be rejected.
- b. The Bidders need to offer its Bid which conforms to Terms of Reference and Terms and Conditions provided as part of this RFP Document.
- c. In a first step, evaluation of Technical Bid will be carried out as specified in Clause 8.2 of SECTION III. Based on Technical evaluation, the Price Bids of only Bidder’s meeting Responsiveness Criteria, Pre-Qualification Criteria and Qualification criteria as specified in clause 8.2(a) and 6.1 shall be opened.
- d. In the second stage, a Price Bid Evaluation of Technically Qualified Bidders will be carried out as per Clause 7.3 and 8.2. The Bids will finally be ranked from the lowest to highest according to their quoted rate specified in price bid.

### 2.2. Due Diligence

The Bidders are encouraged to examine and familiarize themselves fully about the nature of assignment, scope of work, all instructions, forms, terms and conditions of RFP, local condition and any other matters considered relevant by them before submitting the Bid by paying a visit to the site, sending written queries to GMDC, and attending a Pre-Bid meeting.

### 2.3. Acknowledgement by Bidder

By submitted the bid or proposal, the bidder acknowledges that:

- 1) made a complete and careful examination of the RFP
- 2) accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of GMDC relating to any of the matters referred to in Clause 1.2 above; and

3) acknowledged that it does not have a Conflict of Interest

4) agreed to be bound by the undertakings provided by it under and in terms hereof.

GMDC shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to the RFP or the Bidding Process, including any error or mistake therein or in any information or data given by GMDC.

#### **2.4. Cost of Bidding**

The Bidders shall be responsible for all of the costs associated with the preparation of their Bids and their participation in the Bid Process. GMDC will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

#### **2.5. RFP Fee**

a) Bidder will need to submit nonrefundable RFP Document/Tender Fee of **INR 17,700 (i.e RFP fees of INR 15,000 plus 18% GST)**. ### 3. GENERAL

#### 3.1. Bid Validity

- a) Bids shall remain valid for a period of not less than 180 days (One Hundred and Eight days) from the Bid Due Date/Bid Submission Date (the “**Bid Validity Period**”). The Bid of the Bidder shall be considered non-responsive if such Bid is valid for a period less the Bid Validity Period.
- b) In exceptional circumstances, prior to expiry of the original Bid Validity Period, Authority may request the Bidders to extend the period of validity for a specified additional period. The request and the responses thereto shall be made in writing. A Bidder may refuse the request without forfeiting his Bid Security/EMD. A Bidder agreeing to the request will not be required or permitted to modify his Bid but will be required to extend the validity of his Bid Security/EMD for the period of the extension, and in compliance with Clause 3.5 of RFP SECTION III in all respects.

#### 3.2. Numbers of Bids by Bidder

No Bidder shall submit more than one Bid pursuant to this RFP. If a Bidder submits or participates in more than one Bid, such Bids shall be disqualified.

#### 3.3. Governing Law and Jurisdiction

The Bidding Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Ahmedabad shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.

#### 3.4. Authority’s Right to Accept or Reject or Split any Bids or all Bids

- a) Notwithstanding anything contained in this RFP, GMDC reserves the right to accept or reject or split any Bid and to annul the Bidding Process /Bid Evaluation Process and reject for split all Bids, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
- b) GMDC does not bind itself to accept the lowest bid and reserves the right to reject any or all the bids without assigning any reasons whatsoever and to split up the work between two or more bidder(s) or accept the bid in part and not in its entirety.
- c) It shall be deemed that by submitting the Bids, the Bidder agrees and releases

GMDC, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/ or performance of any obligations hereunder, pursuant hereto and/ or in connection with the Bidding Process and waives, to the fullest extent permitted by applicable laws, any and all rights and/or claims it may have in this respect, whether actual or contingent, whether present or in future.

- d) Without prejudice to the generality of Clause (a) and (b) above, GMDC reserves the right to reject any Proposal/Bid if:
- 1) Bid does not meet the Pre-qualification qualification criteria specified in this RFP
  - 2) at any time, a material misrepresentation is made or discovered, or
  - 3) The Bidder found to be indulging in Fraudulent and Corrupt Practices as defined in this RFP.
  - 4) the Bidder does not provide, within the time specified by GMDC, the supplemental information sought by GMDC for evaluation of the Bid.
  - 5) Bidder submits conditional Bid.
- e) If such disqualification / rejection occurs after the Bids have been opened and the Preferred Bidder as per award criteria gets disqualified / rejected, then GMDC reserves the right to consider the next best Preferred Bidder, or take any other measure as may be deemed fit in the sole discretion of GMDC, including annulment of the Selection Process.

### 3.5. Earnest Money Deposit (EMD)/Bid Security

- a) The bidder shall furnish, a separate Bid Security (also referred to as "Earnest Money Deposit" (EMD)/ Bid Security") for Captioned work as part of his Bid as per the given format. The Bid Security/EMD shall be sealed in a separate sealed envelope along with RFP Fees and super scribing "Earnest Money Deposit and RFP Fees ". An Earnest Money Deposit of amount **INR 4 lacs (INR Four Lacs)** shall be provided in favour of "**Gujarat Mineral Development Corporation Ltd**", in any one of the following forms/formats.   - ii. An irrevocable Bank Guarantee (the "**Bank Guarantee**"), payable at Ahmedabad from Approved Bank to Authority as per the Annexure 11 and valid for a period of 210 days (Two Hundred and Ten Days) from the Bid Due Date in the format prescribed in the bid documents. The validity of Bank Guarantee may be extended as may be mutually agreed between Authority and Bidder from time to time as per clause 3.1 of RFP SECTION III. In case Bidder intends to provide Bank Guarantee then it should be provided Compulsory e-Bank Guarantee

- b) Any bid not accompanied with valid Earnest Money Deposit and RFP fee in the acceptable amount, form and validity period will be summarily rejected by GMDC as being non-responsive and bids of such Bidder shall not be evaluated further.
- c) GMDC shall not be liable to pay any interest on the Bid Security/EMD deposit and the same shall be interest free. The EMD shall be furnished in Indian Rupees only.
- d) The Bid Security of unsuccessful Bidders will be returned directly to their account digitally only by GMDC, as promptly as possible on acceptance of the Bid of the Preferred Bidder or if and when GMDC cancels the Bidding Process.
- e) The Preferred Bidder's EMD will be returned, without any interest, upon the Preferred Bidder signing the Agreement and furnishing the Performance Security in accordance with the provision thereof or if and when GMDC cancels the bidding.
- f) GMDC shall be entitled to forfeit and appropriate the Bid Security as Damages inter alia in any of the events specified below. The Bidder, by submitting its Bid, shall be deemed to have acknowledged and confirmed that GMDC will suffer loss and damage on account of withdrawal of its Bid or for any other default by the Bidder during the period of Bid validity as specified in this RFP. ### 4.2. Clarification to RFP Documents

- a) Bidders requiring any clarification on the RFP may notify GMDC in writing through email at the address provided in clause 2.6. They should send in their queries on or before the date mentioned in clause 2.6 section in order to enable Authority to have adequate notice of the said queries so that the same can be addressed in time. GMDC is not bound to take cognizance of any queries raised after the date mentioned in the Bid Sheet Section for sending queries.
- b) GMDC shall endeavor to respond to the questions raised or clarifications sought by the Bidders. However, GMDC reserves the right not to respond to any question or provide any clarification, in its sole discretion, and nothing in this Clause shall be taken or read as compelling or requiring GMDC to respond to any question or to provide any clarification.
- c) GMDC may also on its own motion, if deemed necessary, issue interpretations and clarifications and amendment to RFP. All clarifications and interpretations issued by GMDC shall be deemed to be part of the Bidding Documents. Verbal clarifications and information given by Authority or its employees or representatives shall not in any way or manner be binding on GMDC.

### 4.3. Amendment and corrigendum of Bidding Documents

- a) At any time prior to the Bid Due Date, GMDC may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the RFP by the issuance of Addenda/corrigendum.

In such event, all rights and obligations of Authority and Bidders previously subject to the earlier deadline will thereafter be subject to the Bid Due Date as extended. Any such change in the Bid Due Date shall be notified to the Bidders by dissemination of requisite information in this behalf by uploading the Addenda on Authority website of GMDC and **[www.gmdc.nprocure.com](http://www.gmdc.nprocure.com)**.

#### **5.6. Late Submission**

- a) Physical submissions for Technical Bid and EMD & RFP fees received by GMDC after the specified time and Date shall not be eligible for consideration and shall be summarily rejected.
- b) Authority shall not be responsible for any delay or non-receipt / non-delivery of any documents/ or technical issues pertaining to online Bid. The bidder is expected to take its registration for e tendering well in time and complete all procedure relating to e submission well in time so that there is time for handling any technical glitches. Bidders who are not familiar with the procedure for online bidding may advantage

#### **5.7. Modification and Withdrawal of Bids**

- a) Bidder shall not be able to modify any part of its Bid after the Bid Due Date. In order to avoid forfeiture of Bid Security, a Bidder may withdraw his Bid after online submission thereof. The Bidder may online modify, substitute or withdraw its bid after submission, prior to the Bid Due Date and time.
- b) Any alteration/ modification in the Bid or additional information supplied subsequent to the Bid Due Date, unless the same has been expressly sought for by GMDC, shall be disregarded.

### **6. BID EVALAUTION CRITERIA**

All bids must be considered responsive as described in **clause 8.2 (a)** in order to be considered fit to be evaluated. To be considered eligible and qualified, each Bidder should meet Eligibility Criteria specified hereunder will progress to the next stage of Bid opening.

#### **6.1. Pre-Qualification Criteria**

A Bidder must meet Pre-Qualification Criteria are specified hereunder in order to qualify for next stage of evaluation.

- a) Bidders including an individual, proprietorship firm, partnership firm, company registered under Companies Act, any legal entity or joint ventures/consortium. The Bidder shall be a legal entity registered in India under the relevant legislation.
- b) The Bidder must have an average annual turnover of **Rs 50 Lacs** (Rs Fifty lacs ) per annum in last three financial years ending on 31<sup>st</sup> March 2021 i.e. 2018-19,2019-20,2020-2021.

- Profit & Loss statement
- Certificate of statutory auditor certifying turnover of the bidder for the 03 (three) preceding financial year i.e. 2018-19,2019-20, 2020-2021

- c) The bidder should have a minimum strength of 10 (ten) professionals (mining engineers/geologist, surveyors and software experts) having 3 years or more experience on its payroll (non-contractual staff) who have the relevant experience in the drone mapping, geo-spatial dash boarding and surveying sector. (Surveyors must have the requisite competency certificate from DGMS). Additionally, the Bidder shall commit to deploy any special domain area experts in mineral and mining sector as required for this engagement without any additional cost.

- d) The bidder must have DGCA compliant drones for the approvals.
- The copy of valid proof of ownership.
- e) Bidder should produce evidence of having experience of successfully completed similar works for minimum 3000 Hect. during last three years ending last day of the month previous to the one in which RFP is invited, satisfactory progress of ongoing works etc. secured from clients along with self attested copies of documentary evidence preferably photo copies of work experience. It necessary that Bidder should successfully completed atleast one single similar work of 300 Hect out of 3000 Hect. of work, failing which the bidder's bid will not be considered.

Bidder should specifically mention fulfilling of above criteria in his offer along with details of work orders & work completion/execution certificates issued by clients.

Documents Required :

- **Copies of Work Order with Completion Certificate/Continuation Certificates.**

Note : Work / Job Completion Certificate issued by the authorized representative of the client / principal employer indicating scope and value of work to be furnished; where completion letter does not contain scope or value of the assignment in sufficient detail, work order to be additionally furnished; In the event neither of the two documents can be produced, a certificate from the statutory or independent auditor ( to be signed by Chartered Accountant ) can be furnished providing brief description of work, value and confirming receipt of full payment against completion of such work.

- f) The Bidder should not have been blacklisted as on the bid submission date by any Public Sector Undertaking (PSU) / Central or State Government in India / Central or

State Government undertaking. The Bidder shall need to submit Anti Blacklisting Affidavit as per format specified in Annexure 5.

- g) The Bidder should not have Conflict of Interest as per Clause 11.

## 7. FIXED RATE

- I) **The bidder shall quote the firm rates considering all possible escalation during the currency of the contract**
- II) The rates quoted by the bidder shall remain firm during the pendency/currency of the contract and **no price escalation** is consider/payable under this contract on any account for whatsoever reason
- III) No advance payment will be provided.

## 8. EVALUTION PROCESS

### 8.1. Opening of Technical Bid

- (i) GMDC shall open the Technical Bids received to this RFP, at time, date and Place specified in clause 2.6 in the presence of the Bidders who choose to attend. The Bidders' representatives who are present at such opening shall sign a register evidencing their attendance as a witness to the Bids opening process.
- (ii) The Bidder's names, the presence or absence of requisite RFP Fees and Bid Security and such other details as Authority in its sole discretion may consider appropriate, shall be announced at the opening of Technical Bid.
- (iii) GMDC will subsequently examine and evaluate Technical Bids in accordance with the provisions set out hereunder in clause 8.2.

### 8.2. Evaluation of Technical Bid

The Bidders shall be required to submit documents as listed in this RFP document as per **clause 5.4** along with supporting documents. GMDC shall examine and evaluate the Technical Bids as per the evaluation steps specified below.

#### **a) Test of Responsiveness for EMD, RFP Fee, Timely and proper Submission**

- 1) Prior to evaluation of Technical Bids (i.e. Qualification Criteria), GMDC shall determine whether each Bid is responsive to the requirements of the RFP. A Bid shall be considered responsive only if:
  - (i) The Technical Bid is submitted in Hard copy and Price Bid online properly as per the terms of the RFP.
  - (ii) Technical Bid is accompanied by RFP fee and the EMD as specified in the clause 2.5 and 3.5 of ITB respectively.
  - (iii) Physical submission of Technical Bid, RFP fee and EMD is made within

specified timeline.

- (iv) The Bid and physical submissions are received by the Bid Due Date including any extension thereof pursuant hereto;
  - (v) It contains all the information (complete in all aspects) as requested in this RFP and/or Bid Documents (in formats same as those specified in the RFP);
  - (vi) It does not contain any conditionality; and
  - (vii) It is not non-responsive in terms hereof and any other conditions specified elsewhere in RFP.
- 2) GMDC reserves the right to reject any Bid which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained by GMDC in respect of such Bid.
- 3) Evaluation of Pre-Qualification Criteria and document checks of only those Bidders shall be carried out whose Bids determined to be responsive.

**b) Assessment of Pre-Qualification Criteria**

- 1) GMDC shall examine and evaluate the Pre-qualification of each Technical Bid upon determining its responsiveness as per sub clause (a) above.
- 2) The Bidder must meet Pre-Qualification Criteria specified in clause 6.1 and have submitted all documents as per clause 5.4 in order to qualify for next stage of assessment.
- 3) Assessments of technical bids of only those Bidders shall be carried out whose Bids are meeting Pre-Qualification Criteria and submitted all required documents pursuant to sub clause 2) above.
- 4) The Price Bids of only Technically Qualified Bids shall be opened.

**8.3. Opening of Price Bid**

- (i) The Price Bid shall be filled up by the Bidder as per E-Tendering at designated places through <https://gmdc.nprocure.com> as per the indicative format specified in Annexure 8 to this RFP.
- (ii) The Price Bids of only technically qualified Bidders shall be opened online.
- (iii) The time and date of opening of online Price Bids shall be informed to the Bidders who are declared as Technically Qualified Bidders pursuant to sub clause 8.2 (c) in advance. The technically qualified bidders can view the opened price bid at their place and computer.
- (iv) The Bidder quoted lowest rate in price bid shall be generally declared as Preferred Bidder (the "Preferred Bidder") and considered for award after following the due process including negotiation

#### **8.4. Clarification of Bids and Request for additional/missing information**

To facilitate evaluation of Bids, GMDC may, at its sole discretion, seek in writing clarifications / documents / missing information in writing from any Bidder regarding its Bid. If the response from the Bidder is not received by GMDC before the expiration of the deadline prescribed in the written request, GMDC reserves the right to proceed with evaluation process at the total risk and cost of the Bidder.

#### **8.5. Verification and Disqualification**

(i) GMDC reserves the right to verify all statements, information and documents submitted by the Bidder in response to the RFP and the Bidder shall, when so required by GMDC, make available all such information, evidence and documents as may be necessary for such verification. Any such verification or lack of such verification, by GMDC shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of GMDC there under.

(ii) GMDC reserves the right to reject any Bid and/or appropriate the EMD if:

- at any time, a material misrepresentation in terms of misleading or false representation is made or uncovered, or
- Bidder is blacklisted/banned by any Government Agency.
- In case of fraudulent Bid and the Bidder found to be involved in fraudulent and corrupt practice as per RFP Clause 10.
- In case the Bidder has Conflict of Interest as per clause 11.
- a Bidder makes an effort to influence Authority in its decisions on Evaluation process/Selection process.
- while evaluating the Bid, if it comes to Authority's knowledge expressly or implied, that some Bidders may have compounded in any manner whatsoever or otherwise joined to form an alliance resulting in distorting competitive price discovery or delaying the processing of proposal.
- Record of poor performance such as abandoning the work, rescinding of contract for which the reasons are attributable to the non-performance of the Bidder, consistent history of litigation awarded against the bidder or financial failure due to bankruptcy.
- A bidder who submits or participates in more than one Bid under this RFP.

Such misrepresentation/ improper response/blacklisting/record of poor performance shall lead to the disqualification of the Bidder. If such disqualification / rejection occur after the Bids have been opened and the Preferred Bidder gets disqualified / rejected, then GMDC reserves the right to:

- a) invite the remaining Bidders to submit their Bids or
- b) take any such measure as may be deemed fit in the sole discretion of GMDC, including annulment of the Bidding Process.

- (iii) In case it is found during the evaluation of Bids or at any time before signing of the Contract or after its execution and during the period of subsistence thereof, that one or more of the prequalification criteria/ Technical Criteria /conditions have not been met by the Bidder, or the Bidder has made material misrepresentation or has given any materially incorrect or false information, the Bidder shall be disqualified forthwith if not yet appointed either by issue of the LOA or entering into of the Contract, and if the Successful Bidder has already been issued the LOA or has entered into the Contract, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by GMDC to the Successful Bidder or the Contractor, as the case may be, without GMDC being liable in any manner whatsoever to the Successful Bidder or the Contractor. In such an event, GMDC shall be entitled to forfeit and appropriate the EMD or Performance Security, as the case may be, without prejudice to any other right or remedy that may be available to GMDC under the RFP and/or the Contract.

#### **8.6. Contacts during Bid Evaluation**

Bids shall be deemed to be under consideration immediately after they are opened and until such time GMDC makes official intimation of award of contract to the successful Bidder. While the Bids are under consideration, Bidders and/ or their representatives or other interested parties are advised to refrain, save and except as required under the Bidding Documents, from contacting by any means, GMDC and/ or their Contractors/ employees/representatives on matters related to the Bids under consideration.

#### **8.7. Correspondence with Bidder**

Save and except as provided in this RFP, GMDC shall not entertain any correspondence with any Bidder in relation to acceptance or rejection of any Bid.

#### **8.8. Confidentiality**

Information relating to the examination, clarification, evaluation and recommendation for the Bidders shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional advisor advising GMDC in relation to, or matters arising out of, or concerning the Bidding Process. GMDC will treat all information, submitted as part of the Bid, in confidence and will require all those who have access to such material to treat the same in confidence. GMDC may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or GMDC or as may be required by law or in connection with any legal process.

## 9. SELECTION OF CONTRACTOR AND SIGNING OF AGREEMENT

### 9.1. Award of Contract

- (i) Work will be awarded by way of issuance of Letter Of Acceptance to the lowest bidder (L1) without post tender negotiations if the rates are reasonable. If rates are not reasonable, negotiations with L1 only may be undertaken to arrive at a reasonable rate.
- (ii) Successful Bidder shall, within 7 (seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Successful Bidder is not received by the stipulated date, GMDC may, unless it consents to extension of time for submission thereof, appropriate the Bid Security of such Bidder as damages on account of failure of the Successful Bidder to acknowledge the LOA, and the next Eligible and Qualified Bidder may be considered.

### 9.2. Signing of Agreement

- (i) After acknowledgement of the LOA as aforesaid by the Successful Bidder, it shall cause the Successful Bidder, subject to furnishing the performance security as per the RFP provisions, to execute/sign the Agreement within the 30 (thirty) days from the date of LOA (the "Execution Date"). The Successful Bidder shall not be entitled to seek any deviation, modification or amendment in the Draft Agreement
- (ii) The Successful Bidder shall get correct amount of Stamp Duty adjudicated (Stamp Paper of Rs. 100 / Rs. 300 denominations can be used as per requirement), at Ahmedabad in accordance with applicable law, and submit the same in two copies duly stamped and executed within thirty (30) days from the dispatch of Letter of Award. GMDC shall return one copy duly sealed and signed as a token of acceptance of the Contract. Stamp Duty, and any other charges as may be levied under applicable law, shall be paid by the Successful Bidder.
- (iii) After the signing of Agreement, the Successful Bidder shall call the "Contractor".

### 9.3. Performance Security

- (i) The Successful Bidder shall furnish Performance Security to Authority for securing the due and faithful performance of its obligations under the Agreement, within 20 days from the LOA, in the form of Demand Draft or Fixed deposit or an unconditional and irrevocable bank guarantee (Annexure 10) for amount of equivalent to **10% (Ten percent) of total contract Fees of Group -1 and Group – 2 mining projects (without GST) quoted for the Scope of Work** payable to GMDC (the "Performance Security") from Approved Bank to Authority for a period of one year.

**Successful bidder is required to submit DD or renew the BG at least one month prior to the end of each year for a fee equivalent to 10% (ten percent) of the total**

**contract fee for Group -1.** Such performance Security shall be in favor of **Gujarat Mineral Development Corporation Ltd** and admissible and payable at Ahmedabad branch from Approved Bank to Authority. In case of fixed deposit, the same shall be pledge in favor of Gujarat Mineral Development Corporation Ltd.

GMDC may encash the Performance Bank Guarantee if the Contractor fails to renew it within stipulated time period as suggested above, without any prior notice or correspondence to the Contractor. In case of fixed deposit, the same shall be pledge in favor of Gujarat Mineral Development Corporation Ltd.

- (ii) The Contractor shall maintain a valid and binding Performance Security for a Contract Period as mentioned above in clause no. (i). The Contractor shall ensure that the Performance Security shall subsist in full force and effect in terms hereof, throughout the Agreement Period and thereafter until expiry of three months as explained above in clause no. (i) . In case Contract Period is extended then the Contractor shall have to renew Performance Security for a period of extended Contract Period.
- (iii) If the Contractor/bidder, fails to furnish the Performance Security, it shall be lawful for GMDC to forfeit the EMD and cancel the contract or any part thereof.
- (iv) GMDC shall be entitled to forfeit and appropriate the amount of the Performance Security in whole or in part:
  - a) in the event GMDC requires to recover any sum due and payable to it by the Contractor including but not limited to Damages; and which the Contractor has failed to pay in relation thereof; and
  - b) in relation to Contractor's breach in accordance with the terms contained in the Agreement.
- (v) At any time during the Validity Period, the Performance Security has either been partially or completely been encashed by GMDC in accordance with the provision of the Agreement. The Contractor shall within 15 (fifteen) days of such encashment either replenish, or provide a fresh performance security, as the case may be, failing which GMDC shall be entitled to terminate this Agreement.
- (vi) At the end of the Contract Period, the Performance Security shall be returned to the Contractor without any interest, subject to any deductions which may be made by GMDC in respect of any outstanding dues under the terms of the Agreement.

#### **9.4. Commencement of Work/Assignment and submission of Final Deliverables**

Contractor shall commence and complete the work/assignment between 1<sup>st</sup> April and 15<sup>th</sup> May or such other dates as may be mutually agreed upon. If the Contractor fails to sign the Agreement as specified in Clause 9.2, commence & complete the assignment and submission of final deliverables as specified herein, GMDC may invite the second ranked Bidder for negotiations. In such an event, the LOA or the Agreement, as the case may be, may be cancelled / terminated.

### 9.5. Proprietary Data

Subject to the provisions of Clause 7.8, all documents and other information provided by GMDC or submitted by Bidder to GMDC shall remain or become the property of GMDC. Bidder and the successful bidder, as the case may be, are to treat all information as strictly confidential. GMDC will not return any Bid or any information related thereto. All information collected, analyzed, processed or in whatever manner provided by the successful bidder to GMDC in relation to the Assignment pursuant to TOR shall be the property of GMDC.

### 9.6. Tax Liability

- (i) The rates quoted in Price Bid Annexure 11 shall be inclusive of all taxes, duties, surcharge Levies etc. as applicable ("Price Quote") except applicable Goods and Service Tax. Applicable GST at the time of invoicing shall be reimbursed by GMDC. Future tax)
- (ii) Any other fresh imposition of taxes or levies or variation in existing taxes & levies etc. during the currency of the contract by the Govt. if applicable after submission of the bid and payable by the successful bidder, shall be reimbursed by GMDC on actual subject to submission of documentary proof of having remitted the same and to the extent directly related to the services rendered by the successful bidder under this contract. This shall be subject to submission of documentary proof clearly mentioning the name of work and respective Bill No.
- (iii) GMDC shall be entitled to deduct tax at source as may be applicable. The TDS certificate(s) shall be submitted as per the due date specified in the Income Tax Act.

## 10. FRAUD AND CORRUPT PRACTICES

- a) The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process and subsequent to the issue of the LOA and during the subsistence of the Contract. Notwithstanding anything to the contrary contained herein, or in the LOA or the Contract, GMDC may reject a Bid, withdraw the LOA, or terminate the Contract, without being liable in any manner whatsoever to the Bidder, if it determines that the Bidder or as the case may be, has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process. In such an event, GMDC shall be entitled to forfeit and appropriate the EMD, as the case may be, without prejudice to any other right or remedy that may be available to GMDC under the Bidding Documents and/ or the Contract, or otherwise. In case of cancellation of Contract, if already awarded, Authority shall be entitled to recover from the Bidder the amount of any loss arising from such cancellation in accordance with provisions of RFP Document.
- b) Without prejudice to the rights of GMDC under sub Clause (a) hereinabove and the rights and remedies which GMDC may have under the LOA or the Contract or otherwise if a Bidder or Contractor as the case may be, is found by GMDC to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive

practice during the Bidding Process, or after the issue of the LOA or the execution of the Contract and/or otherwise, such Bidder or Contractor shall not be eligible to participate in any tender or RFP issued by GMDC during a period of 2 (two) years from the date such Bidder or Contractor as the case may be, is found by GMDC to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practices, as the case may be.

- c) For the purposes of this Clause 10, the following terms shall have the meaning hereinafter respectively assigned to them:
- (i) “**corrupt practice**” means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the actions of any person connected with the Bidding Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of GMDC who is or has been associated in any manner, directly or indirectly, with the Bidding Process or the LOA or has dealt with matters concerning the Contract or arising there from, before or
  - (ii) after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of GMDC, shall be deemed to constitute influencing the actions of a person connected with the Bidding Process); or (ii) engaging in any manner whatsoever, whether during the Bidding Process or after the issue of the LOA or after the execution of the Contract, any person in respect of any matter relating to the Project or the LOA or the Contract or otherwise, who at any time has been or is a legal, financial or technical adviser of GMDC in relation to any matter concerning the Project;
  - (iii) “**fraudulent practice**” means a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the Bidding Process;
  - (iv) “**coercive practice**” means impairing or harming, or threatening to impair or harm, directly or indirectly, any person or property to influence any person’s participation or action in the Bidding Process;
  - (v) “**undesirable practice**” means (i) establishing contact with any person connected with or employed or engaged by GMDC with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Bidding Process; or (ii) having a Conflict of Interest; and
  - (vi) “**restrictive practice**” means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Bidding Process.

## 11. CONFLICT OF INTEREST

- a) The Bidder shall not have a conflict of interest that may affect the Selection Process or the work/assignment (the "Conflict of Interest"). Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, GMDC shall forfeit and appropriate the Bid Security, if available, or as mutually agreed genuine pre-estimated compensation and damages payable to GMDC for, inter alia, the time, cost and effort of GMDC including consideration of such Bidder's Proposal/Bid, without prejudice to any other right or remedy that may be available to GMDC hereunder or otherwise.
- b) GMDC requires that the Contractor provides professional, objective, and impartial advice and at all times hold GMDC's interests paramount, avoid conflicts with other assignments or its own interests, and act without any consideration for future work. The Contractor shall not accept or engage in any assignment that would be in conflict with its prior or current obligations to other clients, or that may place it in a position of not being able to carry out the assignment in the best interests of GMDC.

## 12. MISCELLANEOUS

- a) The Bidding Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Ahmedabad shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.
- b) GMDC, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to;
  - (i) Suspend and/ or cancel the Bidding Process and/ or amend and/ or supplement the Bidding Process or modify the dates or other terms and conditions relating thereto;
  - (ii) consult with any Bidder in order to receive clarification or further information;
  - (iii) retain any information and/ or evidence submitted to GMDC by, on behalf of, and/ or in relation to any Bidder; and/ or
  - (iv) Independently verify, disqualify, reject and/ or accept any and all submissions or other information and/ or evidence submitted by or on behalf of any Bidder.
- c) It shall be deemed that by submitting the Bid, the Bidder agrees and releases GMDC, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/ or performance of any obligations hereunder, pursuant hereto and/ or in connection with the Bidding Process and waives, to the fullest extent permitted by applicable laws, any and all rights and/ or claims it may have in this respect, whether actual or contingent, whether present or in future.

- d) The Contractor shall be deemed to be acting as an independent contractor of Authority. Neither party is authorized to bind the other to any obligation, affirmation or commitment with respect to any other person or entity.

## SECTION IV: CONTRACT FEES AND PAYMENT TERMS

The Contractor shall quote fees for the TOR separately. Authority hereby covenants to pay the Contract Fees to the Contractor for Scope of the Work /TOR specified in SECTION – II of the RFP and as per the Charges and payment terms specified hereunder;

### 1) Contract Fees and Payment Terms of the Contractor's Scope/TOR.

- a) The Prices are being invited and to be quoted for Contractor's scope as per the price bid format specified in Annexure 8 (Format of Price Bid) RFP.
- b) The bidder shall quote the firm rates considering all possible escalation during the currency of the contract**
- c) The rates quoted by the bidder shall remain firm during the pendency/currency of the contract and **no price escalation** is consider/payable under this contract on any account for whatsoever reason
- d) No advance payment will be provided.
- e) The Contractor shall submit invoices for actual work carried out along with the actual survey work completion certificate issued by concerned project authority after actual completion of assigned job and GMDC shall make payment within 21 days of receipt of invoices at corporate office upon verifying the invoice subject to following deduction.
  - i. tax as per provision of Income Tax Act, and other Taxes (and surcharges) applicable in force from time to time
  - ii. Cost of any services provided / material supplied plus 10% administrative charge plus applicable taxes, if any, by the GMDC.
  - iii. Liquidated damages leviable as per clause No.5 of Chapter-V
  - iv. Other deductions, if any
- f) Applicable GST, over and above approved Contract Fees, at the time of invoicing shall be reimbursed by GMDC. The risk of applicability of any taxes, duties and levies except GST, shall rest with the Contractor.

## SECTION V: OTHER TERMS AND CONDITIONS

### 1. GENERAL

#### 1.1. Principles of Interpretation

- a. The table of contents, numbers, headings and marginal headings in this RFP are solely for the purpose of facilitating reference and shall not impact the construction or interpretation of this RFP.
- b. Words importing Persons or Parties shall include firms, companies, corporations, trusts, associations and any organizations, having legal capacity to sue and be sued in their names.
- c. Words importing the singular also include the plural and vice versa where the context requires.
- d. Words importing one gender also include other gender.
- e. In case of ambiguities or discrepancies in this RFP, the following shall apply:
  - (i) Between any value written in numerals and that in words, the latter shall prevail.

#### 1.2. Relationship between Parties

Nothing contained herein shall be construed as establishing a relation of master and servant or of agent and principal as between GMDC and the Contractors. The Contractor shall, subject to this RFP, have complete charge of Personnel performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.

#### 1.3. Rights and Obligations

The mutual rights and obligations of GMDC and the Contractor shall be as set forth in the RFP, in particular:

- a) the Contractor shall carry out the Services in accordance with the provisions of the RFP; and
- b) GMDC shall make payments to the Contractor in accordance with the provisions of the RFP.

#### 1.4. Governing Law and Jurisdiction

The contract shall be construed and interpreted in accordance with and governed by the laws of India, and the courts at Ahmedabad shall have exclusive jurisdiction over matters arising out of or relating to this Contract.

### 1.5. Language

All notices required to be given by one Party to the other Party and all other communications, documentation and proceedings which are in any way relevant to this RFP shall be in writing and in English language.

### 1.6. Table of Content and Heading

The table of contents, headings or sub-headings in this RFP is for convenience of reference only and shall not be used in, and shall not affect, the construction or interpretation of this RFP.

### 1.7. Notices

Any notice, request or consent required or permitted to be given or made pursuant to this Contract shall be in writing. Any such notice request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the party to whom the communication is addressed, or when sent by registered mail, telex, telegram or facsimile to such Party at the address specified hereunder.

### 1.8. Locations

- b) GMDC may, from time to time, designate one of its officials as GMDC Representative.
- c) The Contractor may designate one of its employees as Contractor's Representative. Unless otherwise notified, the Contractor's Representative shall be: -----

## 2. COMMENCEMENT, COMPLETION AND TERMINATION OF CONTRACT

### 2.1. Commencement/completion of Assignment

The Contractor shall commence and complete the Assignment during the period 1<sup>st</sup> April to 15<sup>th</sup> May every year unless otherwise agreed by the Parties.

### 2.2. Termination of contract for failure to commence Services/Assignment

If the Contractor does not commence/complete the Services within the period specified in Clause 2.1 above, GMDC may, by not less than 1 (one) weeks' notice to the Contractor, declare this contract to be null and void, and in the event of such a declaration, the contract shall stand terminated and the Contractor shall be deemed to have accepted such termination.

### 2.3. Contract period

- a) A contract shall remain in place for a period of three years for Group -1 mining projects as outlined in Annexure - 12 from the date of acceptance of LOA and for one year for Group -2 mining projects as outlined in Annexure - 12 from the date of acceptance of LOA.
- b) Subject to satisfactory performance of the Contractor, the Authority may, at its sole discretion, extend this Contract Period beyond three years at similar/negotiated rates for working mines only. If so required, the scope of work may be somewhat modified to reflect the priorities and understanding at the time of extension.

### 2.4 Force majeure

- a) Force majeure is herein defined as any cause which is beyond the control of the Contractor or the GMDC as the case may be which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affect the performance of the contract, such as:
  - i. Natural phenomena such as flood, draughts Cyclone, earthquake and epidemics, declaration of war.
  - ii. Acts of any government, including but not limited to war, declared or undeclared priorities, quantities, embargoes, providing either party shall within fifteen (15) days from the occurrence of such a cause notify the other in writing of such cases
- b) The Contractor will advise, in the event of his having resort to this clause by a registered letter duly certified by the statutory authorities, the beginning and end of the cause of delay, within fifteen days of the occurrence and cessation of such Force Majeure condition. In the event of delay lasting over two months, if arising out of Force Majeure, the contract may be terminated at the discretion of the GMDC.

- c) For delay arising out of Force Majeure, the Contractor will not claim extension in completion date for a period exceeding the period of delay attributable to the causes of force Majeure and neither GMDC nor the Contractor shall be liable to pay extra costs (like increase in rates, remobilization, advance, idle charges for labour and machinery etc.) provided it is mutually established that the Force Majeure conditions did actually exist.
- d) If any of the Force Majeure conditions exists in the place of operation of the Contractor even at the time of submission of bid he will categorically specify them in his bid and state whether they have been taken into consideration in their quotations
- e) The Contractor or the GMDC shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/ or defined above. The date of completion will, subject to hereinafter provided, be extended by a reasonable time given though such cause any occur after Contractor's performance of his obligations has been delayed for other causes.

## **2.5 Termination of Contract**

If at any time during the currency of this contract, any breach occurs due to the reasons attributed to the Contractor, GMDC shall be at liberty to terminate this contract without assigning any reasons, whatsoever, for such termination and any losses and/or damages occurring due to such termination shall be borne by the Contractor. GMDC shall be entitled to forfeit Security deposits as Liquidated damages. No compensation shall be payable by GMDC

## **2.6 Suspension or Foreclosure of Contract**

In case of any necessity arising due any unforeseen reason not in control of the GMDC including local working conditions, land/lease issues during the currency of the contract, GMDC shall be at liberty to conclude/postpone/complete/terminate/foreclose this contract. No compensation or payment shall be made on account of non-completion of the balance qty. work or for whole contract quantity. Decision of GMDC in this regard shall be final and binding to Bidder.

## **3. OBLIGATIONS OF THE CONTRACTOR**

### **3.1. General**

#### **3.1.1. Standard of Performance**

The Contractors shall perform the Services and carry out their obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional techniques and practices, and shall observe sound management

practices, and employ appropriate advanced technology and safe and effective equipment, machinery, materials and methods. The Contractors shall always act, in respect of any matter relating to this Contract or to the Services, as faithful advisers to GMDC, and shall at all times support and safeguard GMDC's legitimate interests in any dealings with Third Parties here IBM.

### **3.1.2. Terms of Reference**

The scope of Services to be performed by the Contractor is specified in the Terms of Reference (the "TOR") at RFP SECTION II. The Contractor shall provide the Deliverables specified therein in conformity with the time schedule stated therein.

### **3.1.3. Applicable Laws**

The Contractor shall perform the Services in accordance with the Applicable Laws and shall take all practicable steps to ensure that any Sub-Contractor, as well as the Personnel and agents of the Contractor and any Sub-Contractor, comply with the Applicable Laws.

### **3.2. Conflict of Interest**

The Contractor shall not have a Conflict of Interest and any breach hereof shall constitute a breach of the Agreement.

#### **3.2.1. Contractors not to Benefit from Commission, Discounts etc.**

The remuneration of the Contractors pursuant to Payment Terms specified in RFP SECTION IV hereof shall constitute the Contractor's sole remuneration in connection with this Contract or the Services and, the Contractors shall not accept for their own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Contract or to the Services or in the discharge of their obligations hereunder, and the Contractors shall use their best efforts to ensure that any Sub-Contractors, as well as Personnel and agents of either of them, similarly shall not receive any such additional remuneration.

#### **3.2.2. Contractors and Affiliates not to engage in Certain Activities**

The Contractor shall hold the GMDC's interest paramount, without any consideration for future work, and strictly avoid conflict with other assignments or their corporate interests.

The clause shall not prohibit the Contractor to serve competing clients and clients with potentially conflicting interests as well as counter-parties in merger, acquisition and alliance opportunities. However, in such cases the Contractor agrees to a professional responsibility to maintain the confidentiality of Client information.

#### **3.2.3. Confidentiality**

The Contractors, their Sub-Contractors and the Personnel of either of them shall not, either during the term or after the expiration of this Contract, disclose any proprietary or confidential information relating to the Project, the Services, this Contract or GMDC's business or operations without the prior written consent of GMDC, provided however

that this clause shall not apply to any information (a) which already forms part of the public domain; or (b) which is received from a third party; or (c) which is independently developed; or (d) which is required to be submitted to any regulatory, statutory or governmental authority.

### **3.3. Insurance to be taken out by the Contractor**

- (i) The Contractor shall procure and maintain, at its own cost, Professional Liability Insurance or other appropriate insurance required as per the Good Industry Practice or Contractor's own standard practices during the Contract Period insurance (the "Insurance"). At the Authority's request, the Contractor shall provide evidences of insurance covers or a certificate of all insurances maintained on request of Authority.
- (ii) The Contractor shall indemnify the Authority for any liability pertaining to loss of any life, health, accidents, travel and any other losses to its personnel including sub Contractor/specialist deployed by the Contractor to perform scope of work specified under this Contract.
- (iii) The Authority undertakes no responsibility in respect of any life, health, accident, travel and other insurance which may be necessary or desirable for the Personnel of the Contractor or its sub-contractors / sub Contractors / specialists associated with the Contractors for the purposes of the Services, nor for any member of any such person

## **4. OBLIGATIONS OF GMDC**

### **4.1. Assistance in clearance**

Unless otherwise specified in the Agreement, GMDC shall make best efforts to ensure that GMDC shall:

- a) provide the Contractor and its Personnel with work permits and such other documents as may be necessary to enable the Contractor or its Personnel to perform the Services;
- b) issue to officials, agents and representatives of GMDC all such instructions as may be necessary or appropriate for the prompt and effective implementation of the Services.**

### **4.2. Documents and Other Support**

GMDC will provide all necessary information/documents/data, which shall include;

- a) GMDC will provide all support required for the assignment.
  - Cadastral plan of areas

- Surface plan of areas
- b) GMDC may provide accommodation at their guesthouses on a chargeable basis, subject to availability. The applicable charges are the same as for GMDC employees on official business.
  - c) Any other information as may be required by the Contractor, subject to internal and external confidential requirements. If necessary, a Non – disclosure Agreement will be signed.

## 5. LIQUIDATED DAMAGES AND PENALTY

- a) If the service provider fails to deliver the services within the delivery period and any extension thereof, unless such failure is due to force majeure situation or due to GMDC's default, liquidated damages (LD) shall be imposed by GMDC on the service provider. However, imposition of LD shall be without prejudice to the other remedies available to GMDC under the terms of the RFP document.
- b) In case of delay in delivery of the services, the LD shall be calculated as 0.5% (zero point five cent) of the value of the Contract value (excluding taxes and duties) in respect of which the delay in delivery has occurred for each week or part thereof of delay, subject to a maximum value of 5% of the value of the Contract value (excluding taxes and duties). GST on LD shall be recovered in addition to the LD amount.
- c) The assignment must be completed between 1<sup>st</sup> April and 15<sup>th</sup> May, or in accordance with any other guidelines / instructions issued by the authority. The deliverables for each mining project should be submitted within 15 days of the completion of that project's survey work.
- d) GMDC shall have full liberty to realise the LD through the following ways:
  - a. Appropriation of the Performance Security;
  - OR
  - b. Appropriation the of EMD (in case provision of Performance Security does not exist);
- e) Any waiver of LD shall be at the sole option/discretion of GMDC only and any extension must be in writing and with the approval of the competent authority of GMDC.

If at any time during the Service Order / Agreement, the service provider encounters conditions that may impact the timely performance of services, the service provider shall promptly notify to GMDC in writing of the fact of the delay, it's likely duration and its cause(s). As soon as practicable after receipt of the service provider's notice, the GMDC shall evaluate the situation and may at its discretion waive the LD on the request of the

## 6. DISPUTE RESOLUTION

### 6.1. Amicable Solution

- (a) Save where expressly stated otherwise in RFP document, any dispute, difference or controversy of whatever nature howsoever arising under, out of or in relation to the contract including incompleteness of the Services/ TOR /Payment between the Parties and so notified in writing by either Party to the other (the "**Dispute**") in the first instance shall be attempted to be resolved amicably by GMDC and Contractor in accordance with the procedure set forth in sub-article (b) below.
- (b) Either Party may require the Dispute to be referred to committee of two senior executives of GMDC and the Contractor, for the time being for amicable settlement. Upon such reference, the committee shall meet at the earliest mutual convenience and in any event within 15 days of such reference to discuss and attempt to amicably resolve the Dispute. If the Dispute is not amicably settled within 15 (fifteen) days of such meeting between the two, either Party may refer the Dispute to an independent Dispute Review Expert (also referred to as adjudicator) who may be an impartial person of experience in legal / dispute matters and both parties mutually select Dispute Review Expert
- (c) Dispute Review Expert shall give a decision in writing within 28 days of receipt of Notification of the Dispute. Reimbursable expense pertaining to Dispute Review Expert shall be divided equally between GMDC and the Contractor. Either Party may refer a decision of the Dispute Review Expert to the Arbitrators within 28 days of Dispute Review Experts written Decision as per the agreement. If neither party refers the dispute to the Arbitration within the next 28 days, the decision of Dispute Review Expert will be final and binding.

### 6.2. Arbitration

#### (a) Arbitrators

Any Dispute/questions/differences whatsoever, which may at any time arise between the parties to this RFP and subsequent contract in connection with the RFP and subsequent contract or any matter arising out of or in relation thereto and which is not resolved amicably as provided in Clause 6.1 shall be finally settled by binding Arbitration under the Arbitration and Conciliation Act, 1996. The Dispute shall be referred for the fast-track Arbitration to sole Arbitrator as per the provisions of Arbitration and Conciliation Act, 1996 and subsequent amendment thereto (clause 29B of said act).

#### (b) Place of Arbitration

The place of arbitration shall be Ahmedabad. The Language of the Arbitration shall be in English only.

#### (c) Procedure

The procedure to be followed within the arbitration, including appointment of arbitrator / arbitral tribunal, the rules of evidence which are to apply shall be in accordance with the Arbitration and Conciliation Act, 1996.

**(d) Enforcement of Award**

Any decision or award resulting from arbitration shall be final and binding upon the Parties. The Parties hereto hereby waive, to the extent permitted by law, any rights to appeal or to review of such award by any court or tribunal. The Parties hereto agree that the arbitral award may be enforced against the Parties to the arbitration proceeding or their assets wherever they may be found and that a judgment upon the arbitral award may be entered in any court having jurisdiction in Ahmedabad only.

**(e) Fees and Expenses**

The fees and expenses of the arbitrators and all other expenses of the arbitration shall be initially borne and paid by respective Parties subject to determination by the arbitrators. The arbitrators may provide in the arbitral award for the reimbursement to the prevailing party of its costs and expenses in bringing or defending the arbitration claim, including legal fees and expenses incurred by Party.

**6.3. Performance during Dispute Resolution**

Pending the submission of and/or decision on a Dispute, difference or claim or until the amicable solution or arbitral award is published; the Parties shall continue to perform all of their obligations under the contract without prejudice to a final adjustment or judgment in accordance with such solution or award.

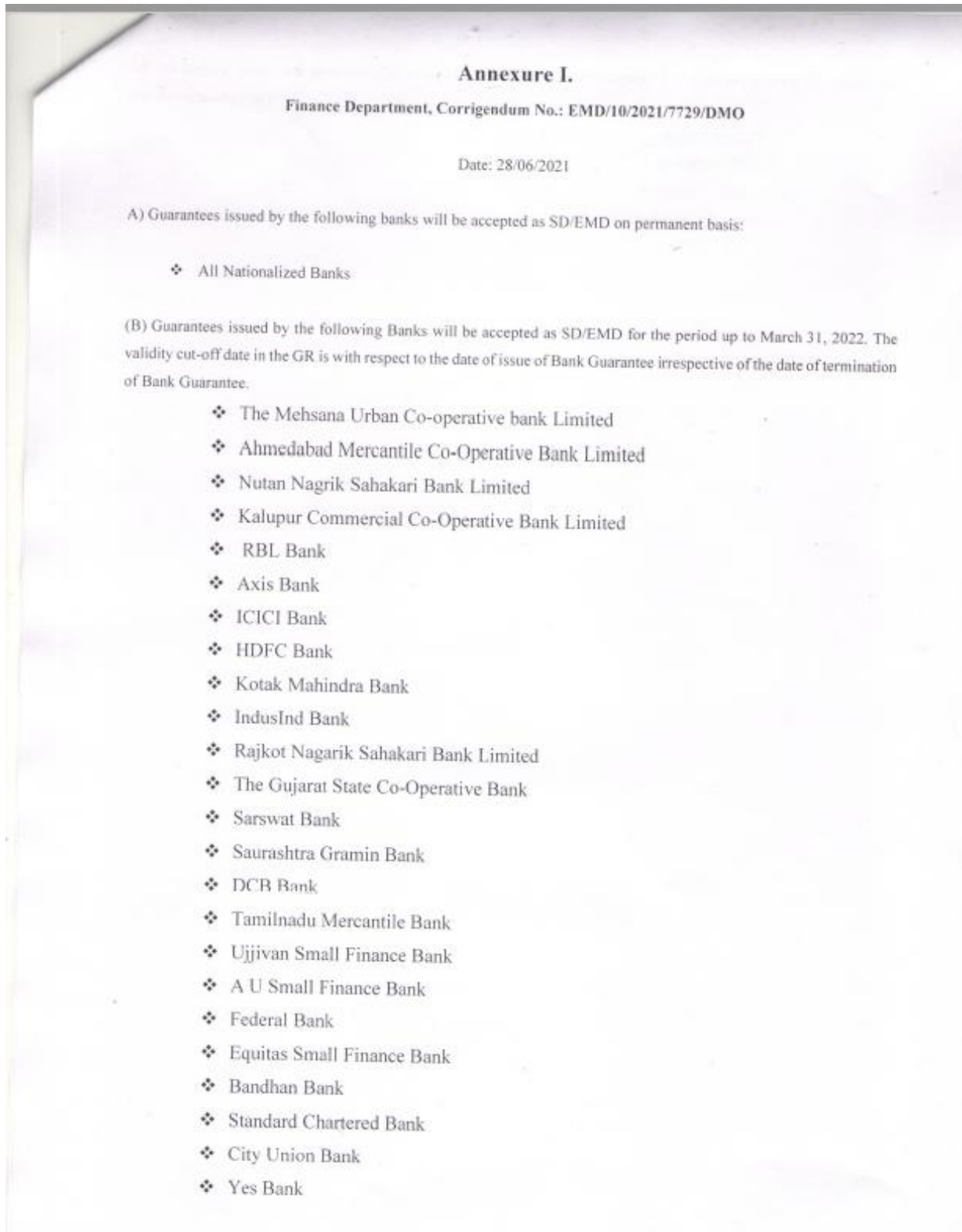


