2. Registration process is directly done by the Corporation. No intermediate agencies are encouraged or welcomed in this regard.
3. Entries in the application form may be type written or filled in legible handwriting.
4. Every column should be properly filled up. Please delete/strike-out inapplicable details.
5. Duly stamped and signed (self attested) legible copies of supporting documents should be enclosed wherever necessary. The list of enclosures should be carefully checked up before submitting the application form. The documents should be placed in the same order as specified in the checklist.
6. Computer data sheet should be enclosed with the application form. Proper industry code should be indicated and if the firm is engaged in production of more than one item, main business should be indicated.
7. All correspondence by GMDC will be addressed on company's registered email or at the company's registered postal address provided on the first page.
8. Proprietor in case of proprietorship concerns, Managing Partner, partners in case of partnership firm and Managing Director in case of limited company should sign application form and for other type authorized representative should sign application form. In all cases authorization of the specific person should be given to GMDC on organization's authorized letterhead.
9. It is mandatory to mention **Email ID, landline No. and Mobile No.** on first page.
