Bidders participating in the e-Auction shall have to quote for individual stacks as per their choice; no fixed minimum quantity for bidding is applicable as the bidding will be for quantity of whole stacks. (Annexure-VII of e-Auction Document) The quality is also mentioned against each stack which is based on GMDC's Laboratory Analysis Reports.

The interested bidders are requested to get themselves acquainted with applicable rules, regulation and governing laws, policies, procedures and other prevailing legalities for the mineral price, royalty, DMF, NMET and other applicable taxes before entering in e-Auction. Interested bidders are also requested to acquaint themselves with the e-Auction service provider and complete registration formalities before entering in e-Auction.

To participate in e-Auction Bid Security Amount of Rs. 5 Lakh is mandatory, the same shall be payable via Demand Draft in favor of ‘GMDC Ltd.’ payable at Ahmedabad or by electronic transfer through RTGS/NEFT in the Account no. & IFSC Code mentioned in the e-Auction Tender Document, The details of amount deposited as Bid Security is mandatory to be mentioned in Form-A, with all required documents.

In order to participate in e-Auction USER ID & Password (Digital Signature Certificate) issued by nProcure are required. The instructions for the same are given in the document itself as Annexure-IV in the e-Auction Tender Document.

The e-Auction will be held in 02 stages, stage-01 will consist of prequalification for bidding in e-Auction based on documents submitted by bidders and stage-02 will be for online bidding of offers for individual stacks and successful bidders will be selected based on highest offer price (H1) for the individual stacks.
