Government of Gujarat has appointed Gujarat Mineral Development Corporation Ltd.(GMDC Ltd.) Ahmedabad as " State Nominated Agency (SNA)" vide GR no TPS/102022/403/CHH dated 22.03.2022, for distribution of coal from subsidiaries of Coal India Limited to medium, small, micro and other industrial units having annual requirement of coal up to 10000 Tonnes, in accordance with the " New Coal Distribution Policy-2007" of Ministry of Coal, Government of India.

After due process, GMDC executed a Fuel Supply Agreement with Western Coalfields Limited for the period 2025-26 on 12.08.2025 (Contract Code: 3020040916), for an ACQ of 62792 MT.

As per Clause 4.4 of Fuel Supply Agreement the State Nominated Agency shall submit to the State Government a Quarterly return as per schedule VI of FSA; it is also to be mentioned that as per clause 4.4 of FSA" The Purchaser shall submit to the state government, a Quarterly Return as per schedule VI giving month wise, consumer-wise, unit-wise details of Coal sold. Such details should essentially include name, address, and contact no. of consumer, type & location of unit, quantity lifted during the month and the price at which coal was supplied for evaluation of genuine consumption and monitoring of the same by State Government. Such particulars shall be hoisted by the purchaser (in this case GMDC Ltd) and the state Nominating Authority (in this case Government of Gujarat) in their respective websites on regular basis."

Accordingly, we are hereby submitting the quarterly return for the period of July 2025 to September 2025 containing the required details, attached with this letter as Schedule VI for FSA 2025-26. We have uploaded the quarterly return on the website of GMDC. You are kindly requested to upload the same on the official website of the Industries & Mines department.
