1. Income Tax, Sales Tax TDS, Turn over tax etc. etc. as per the provision of respective act from time to time.
2. Security Deposit & Retention Money.
3. Cost of any services provided by the Employer and/or material supplied by the employer.
4. RA/Final bill must be submitted along with the names of the labourers employed for the work, salaries paid to them, amount of P F deducted from the salary of the labourers and employer's contribution amount deposited in RPFC against each labour name and copy of the challans for the amount deposited in RPFC office till previous month duly certified by the project office.. Contractor has to maintain wages register and the same will have to be certified by the Engineer In charge.

Other deduction either statutory or for any reason, if any.

5. Earnest money deposit [EMD] and Security Deposit [SD] will not bear any Interest.

**INSTRUCTIONS BEFORE QUOTING THE TENDER**

1. If the party does not accept the work order, issued by GMDC, then the amount of the EMD paid by the party will be forfeited.
2. Tenderer is required to quote the rates strictly as per the terms and conditions mentioned in the tender document. Any conditional tender will not be entertained and will be rejected.
3. Tenderer is required to visit the site along with the purchased tender copy, to study the actual working condition before submitting the offer.
4. Successful tenderer is required to insure the whole work and their personnel under Workmen Compensation Act against any accident, minor and major injuries arising out of the work situation.
5. The successful tenderer shall have to start the work within expiry of the period of 15 days from the date of receipt of the Letter of Intent. In case of non-compliance of the above condition the contract may be terminated.
6. The rate quoted is inclusive of all labor and material required for the Job.
7. The total works under this tender is with a 'providing and laying/fixing' the materials. In the event of missing of above phrase in the description of schedule of quantities, will not mean that materials will be supplied by the client and tenderer has to deploy only labors for completing the items.
8. Quantity mentioned in schedule of quantities against each item is only for guidance to quote the rate and no claim will be entertained on either increase or decrease in the quantity.
9. Water for the execution and curing & electricity will have to be managed by the tenderer at his risk and cost. However, if possible water and electricity will be supplied by corporation at a 1% of bill amount against water charge and actual charge of electricity against power consumption. Electric meter is to be installed by the contractor.

10. No escalation in price/rate will be allowed on any ground. Even if there is a delay in completion of the work due to client, then extension in time limit may be granted with an explicit understanding that no price escalation will be paid.
11. In absence of detail specification, the work should be carried out based on either relevant IS code and/or fair engineering practice prevailing in the market.
12. All the rates quoted by the tenderer must be inclusive of all taxes, duties, Octrai, transportation, labor, sales tax, turn over tax, loading, unloading & **But excluding the applicable GST .**
13. Successful tenderer will have to submit the three copies of the detail bar chart in the manner as per the Performa issued by the client for timely completion of the work.
14. Tenderer is required to submit the copy of the PF Registration nuctmber received from RPFC Office, along with the tender. However, each R A Bill must be submitted along with the name of the labour/employee deployed for the work salaries paid to them, amount of PF deducted from their salaries employees and employer's contribution, amount deposited in RPFC Office against each labor name and copy of the challan for the amount deposited in RPFC office till previous month duly certified by the project office, failing which no payment will be made for the RA Bill submitted by the contractor at Project/HO. Further, successful tenderer will have to submit the name of the labor/employee deployed for the work, salaries paid to them, amount of PF deducted from their salaries, employees and employer's contribution, along with the running bills.
15. The tenderer will have to submit **'NO DEMAND CERTIFICATE'** along with the final bill of the work, as per the Performa given earlier.
16. Successful tenderer is supposed to enter in to the agreement with the corporation on a appropriate stamp paper [to be provided by the contractor] after accepting the Letter of Intent and having agreed to and accepted the terms and conditions of the tender.

17. Any material issued by GMDC will be from GMDC stores. The transportation arrangement will be borne by contractor.
18. Successful tenderer have to submit royalty clearance certificate at the time of releasing of SD, if applicable..
19. Successful tenderer have to make payment to their employees through bank account only.
20. The cost of executed work (all tender items together) varies beyond (+/-) 10% of the tender value even if the quantities increase to any extent the present rate as mentioned will hold good and no price escalation will be allowed the quoted rates shall remain valid till completion of works from the date of the work order whichever is later.
21. Applicable GST will be paid/adjusted/reimbursed to the contractor as per the prevailing rates & rules to the extent directly related to the service Rendered or goods supplied by the successful bidder under the said contract subject to production of documentary proof and contractor will mention the GST amount separately in the invoice/bill along with SAC|HSN code under GST. Further if the bidder does no upload the invoice within four months from the invoice date on GSTN portal GST will not be reimbursed to them.
22. Successful tenderer shall have to obtain license under the Bombay shop and Establishment Act and it shall pay wages and benefits in accordance with the applicable laws and shall not pay less than as notified by the Government Authorities from time to time and shall maintain the employment records as required under applicable laws.
