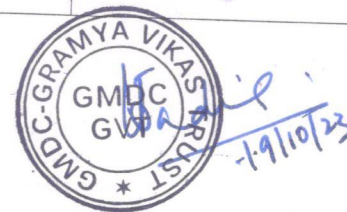

1	Article 27 Payment Terms (Page No. 27)	Will there be a batch wise payment release to the agency.	Payment shall be released to the agencies as per the payment criteria and stages mentioned in Article 27 (Payment Terms)
2.	Batch Size	Could the agency consider changing the batch size according to the course?	The batch size shall remain of 30 candidates for all the courses to be undertaken under GMDC Odisha Samarthya.
3.	Article 13 (Bid Security /Earnest Money Deposit) (Page No. 20)	At Page: 02 bid security amount is Rs. 50,000/- while at Page 20 Bid Security Amount is Rs. 1 Lakh.	Bid Security Amount shall remain as Rs. 50,000/-
4.	Handholding Support	Placement Criteria and Handholding Support	The candidate shall be considered as placed once candidate completes one month at the job location. Agency shall be required to provide 6 months of handholding support to all the placed candidates.

5.	Salary Consideration Criteria	What will be considered as candidate's salary (Cost to Company (CTC) or In-hand Salary?)	For the calculation of Candidate's salary, CTC shall be considered. However, agency should try that candidate shall get at least Rs. 15,000/- CTC Per Month job.
6.	EMD submission as Bank Guarantee	Will GMDC-GVT allow EMD in form of Bank Guarantee?	As per the tender criteria, EMD shall be accepted only in form of Demand Draft (DD).
7.	Center Location	Can agency set-up training facilities and centre at Bhubaneswar?	Yes. Selected agencies have the option to establish their training facilities and centers in Bhubaneswar or any other location that offers suitable facilities and infrastructure. We encourage agencies to consider setting up their training hubs in areas that provide conducive environments for effective training and skill development.
8.	Candidate Certification	Consideration of Third Party Bodies for Assessment and Certification from the affiliated bodies.	Yes, the possibility of involving third-party organizations for assessment and certification bodies will be considered and same will be communicated to the selected agencies.
9.	Eligibility Criteria	Agencies requested for the relaxation in Eligibility Criteria.	No relaxation in the eligibility criteria will be considered. The eligibility criteria shall remain as specified on Page 16, Article 3 of the RFP document.
10.	Page 30 (Table 2: MAJOR SECTORS)	Can bidder propose other job roles than the listed in the page?	Bidder can propose any job role outside the Table:2 but within the same sector as specified in the RFP Document.
11.	Earnest Money Deposit (EMD)	Government Institutions and entities registered as MSME requested for waving EMD.	Government Institutions and entities registered as MSME shall submit the relevant central/state government notification and certificate applicable for waving off EMD.

12.	Training Target	What will be the Training Target allocated to each bidder for a period of one year?	GMDC-GVT will initially allocate training target after the technical assessment of PIA. Based on the performance and capacity of bidder and the type of courses offered by the agencies, additional target will be allocated by GMDC-GVT as per the performance.
