Online tenders under two-bid systems are hereby invited for hiring of Jeep/Bolero/Utility of model year 2024 or there after year to operate on contract basis for different projects of GMDC as per details given herein below:-

- (1)** The estimated details of vehicles and their requirement of projects are as under which is subject to vary according to the future requirement of the GMDC. It is compulsory to submit rates online for the present requirement of Jeep/Bolero/Utility.

The quantity of above vehicles shall be increased and/or decreased as per the requirement of GMDC at relevant point of time. The present requirement is as above. The contractor shall have to provide vehicle from any of the above vehicles required at any of the projects/head office of the Corporation during the contract period with the same rate/condition.

(2) Duration of Contract:

The duration of the Contract shall be of two years from the date of award of contract, which may be extended for a further period of one year on the same terms and conditions of the contract taking into consideration the requirement of the GMDC and the quality of services provided by the contractor. After completion of extension for a period of One year, the contract may be further extended as per mutual agreement between the parties if required.

(3) Validity of Tender Offer:

The offer of the concerned party shall remain valid for 120 days from the date of opening the Online Tender and if required by the GMDC, the said offer shall be treated valid for further period of 60days.

Work Order for execution of contract shall be issued to the Bidder whose tender is accepted. Immediately after the receipt of the work order, the successful bidder shall carry out procedure regarding deployment of his vehicles within the 60 days so as to start work.

The GMDC reserves the right to accept or reject any bid, without assigning any reason of whatsoever in nature, or to accept whole or a portion of tender as it may deem fit, or to assign work to more than one party.

It is necessary that interested parties may carryout self-study of the site condition before submitting their offers. In case of site visit has been not it is presumed that party has been aware of site locations.

(4) Eligibility Criteria of the Bidder

(a) The bidder should have any of the following type of work experience at least three years for providing vehicles to Government/Semi Government / Municipality / Corporation/Private Company in the last seven years from 01.03.2017 to 29.02.2024. Certified workorder /experience certificate copy of the same shall be submitted.

1. 3 Similar works costing not less than 40 % of the estimated contract value i.e \ Rs. 2.94 Crores (Excluding Taxes).

2. 2 Similar works costing not less than 50 % of the estimated contract value i.e Rs. 3.675 Crores (Excluding Taxes).
3. 1 Similar works costing not less than 80 % of the estimated contract value i.e Rs. 5.88 Crores (Excluding Taxes).

“Similar work means and includes to providing light motor vehicles i.e. Van, Jeep, Car and other light motor vehicles to any Government/Semi Government / Municipality / Corporation/Private Company.”

- (b) Bidder shall submit Balance Sheet for the financial year 2022-23 and a copy of I.T. Return. The bidder shall have average turnover of 30 % of the estimated contract value i.e. 2.21 Crore for the last three financial years. The estimated contract value is mentioned above. The Balance Sheet should be audited by a chartered accountant and Membership Number of the chartered accountant shall be affixed on the balance sheet. If the partnership firm is created in recent past than in that case the I.T. Return of the individual person may be taken into consideration for the purpose of qualification of the bidder.

Note: Following documentary evidence should be submitted with respect to (a) and (b) above pertaining to single work order, balance sheet, I.T. Return etc. If the prospective bidder fails to submit the aforementioned documents alongwith the technical bids, then the bids submitted by the bidder shall be outrightly rejected without assigning any reason whatsoever in nature.

The term ‘Bidder’ for the above purpose shall include following:

- The person/proprietor who has quoted rates with reference to the Tender, and or
 - If the bid is submitted by the firm, that firm, and or
 - If the bid is submitted by the Partnership firm than that partnership firm of partners of the firm and or
 - If the bid is submitted by the company, that company.
- (a) The decision of the GMDC with regard to deciding the overall eligibility of a bidder after evaluation of technical bid shall be final and binding to the bidders.
 - (b) GMDC reserves right to ask any additional information/documents from any bidders after opening of technical Bid.
 - (c) Complete details as desired in the tender document along with relevant documents shall be submitted online system/in person in a sealed envelope. Demand Draft for tender fee and earnest money shall be submitted along with the same in the name “GMDC Ltd., Ahmedabad”. Online tender without tender fee and earnest money shall not be accepted. The tender processing fee and earnest money draft along with

the technical bid must reach at the registry department on 2nd Floor on or before date:30/03/2024 at 18:00 hours.

(5) Tender Processing Fee

- a) Bidder will need to submit nonrefundable RFP Document/Tender Fee of INR 17,700 (i.e., RFE fees of INR 15,000 plus 18% GST). The RFP Document Fees shall be submitted (i) in the form of a Demand Draft in favor of “Gujarat Mineral Development Corporation Limited” and payable at Ahmedabad along with the Bid as per marking and sealing section or (ii) by depositing the stated amount directly into GMDC bank account through NEFT/RTGS. In such a case, while submitting the online bid on npcocure, when Bidders are prompted to input the DD number, the Bidder may enter the NEFT/RTGS transaction number. - b) If payment is made through electronic mode, then Bidder shall submit the receipt of the same in the technical bid documents.
- c) In case of Demand Draft then Demand Draft shall be from any bank among the list of scheduled commercial Bank in India published by RBI. This demand Draft for RFP document shall be non-refundable. Bids that are not accompanied by the RFP fees in acceptable amount and form shall considered non- responsive and shall be summarily rejected.
- d) Relaxation in terms of submission of RFP Fee shall be given to the bidder who is holding valid Certificate issued under the MSME Act, 2006 on the date of submission of bid to this RFP.

(6) Earnest Money Deposit (EMD)/Bid Security

- a) The bidder shall furnish, a separate Bid Security (also referred to as "Earnest Money Deposit" (EMD)/ Bid Security") for Captioned work as part of his Bid as per the given format. The Bid Security/EMD shall be sealed in a separate sealed envelope along with RFP Fees and super scribing "Earnest Money Deposit and RFP Fees ". An Earnest Money Deposit of amount INR 22,05,000/- (INR Twenty Two Lakhs Five Thousand) shall be provided in favor of “Gujarat Mineral Development Corporation Ltd”, in any one of the following forms/formats. The List of Approved Banks is provided in Annexure I.
- i. Account payee Demand Draft /Banker’s Cheque from any bank among the list of scheduled commercial Bank in India published by RBI.

- ii. An irrevocable Bank Guarantee (the “Bank Guarantee”), payable at Ahmedabad from Approved Bank by the Government of Gujarat from time to time (except Cooperative Banks) to GMDC as per the Annexure I and valid for a period of 210 days (Two Hundred and Ten Days) from the Bid Due Date in the format prescribed in the bid documents (Annexure H). The validity of Bank Guarantee may be extended as may be mutually agreed between Authority and Bidder from time to time. In case Bidder intends to provide Bank Guarantee then it should be provided Compulsory e-Bank Guarantee Confirmation through ICICI Bank through SFMS1 under our IFS Code: ICIC0000024 and UIC GMDC530265584 for Field 7037. Bank Name: ICICI BANK LTD.
- b) Relaxation in terms of submission of EMD shall be given to the bidder who is holding valid Certificate issued under the MSME Act, 2006 on the date of submission of bid to this RFP.
- c) Any bid not accompanied with valid Earnest Money Deposit and Tender Processing fee in the acceptable amount, form and validity period will be summarily rejected by GMDC as being non-responsive and bids of such Bidder shall not be evaluated further.
- d) GMDC shall not be liable to pay any interest on the Bid Security/EMD deposit and the same shall be interest free. The EMD shall be furnished in Indian Rupees only.
- e) The Bid Security of unsuccessful Bidders will be returned by GMDC, as promptly as possible on acceptance of the Bid of the Preferred Bidder or if and when GMDC cancels the Bidding Process. Bidders may by specific instructions in writing to GMDC give the name and address of the person in whose favor the said demand draft shall be drawn by GMDC for refund, failing which it shall be drawn in the name of the Bidder and shall be mailed to the address given on the Bid.
- f) The Successful Bidder’s EMD will be returned, without any interest, upon the Successful Bidder signing the Agreement and furnishing the Performance Security in accordance with the provision thereof or if and when GMDC cancels the bidding.
- g) GMDC shall be entitled to forfeit and appropriate the Bid Security as Damages inter alia in any of the events specified below. The Bidder, by submitting its Bid, shall be deemed to have acknowledged and confirmed that GMDC will suffer loss and damage on account of withdrawal of its Bid or for any other default by the Bidder during the period of Bid validity as specified in this RFP. No relaxation of any kind on Bid Security shall be given to any Bidder.
- i. If a Bidder withdraws its Bid during the Bid Validity Period as specified in this RFP and as extended by mutual consent of the respective Bidder(s) and

- ii. In the case of Successful Bidder, if it fails within the specified time limit –
 - 1) to sign and return the duplicate copy of LOA
 - 2) to sign the Agreement within the time period specified by GMDC.
 - 3) to furnish the Performance Security within the period prescribed therefore in the RFP; or
 - 4) In case the Successful Bidder, having signed the Contract, commits any breach thereof prior to furnishing the Performance Security.

(7) General Terms and Conditions

- (i) The bidder shall quote rates for vehicles as per the project mentioned at work description. It is desirable that the bidder offers rates in accordance with his financial and administrative capabilities.
- (ii) The GMDC reserves right to accept or reject any bid or to accept whole or a portion of tender as it may deem fit, or to assign work to more than one party.
- (iii) Each bidder shall quote rates for vehicles as per Annexure 'B' through online only.
- (iv) Each bidder shall furnish complete details of regarding experience as per Annexure 'A' shall be submitted. The bidder shall submit both these statements along with necessary proof in hard copy along with the technical bid.
- (v) The bidder whose bid is accepted shall have to enter into an agreement on Rs 300/- non-judicial stamp paper (to be provided by the contractor) within 30 days from the date of acceptance of L.O.I.
- (vi) The work order shall be issued to the bidder whose bid is accepted. The bidder shall carry out procedure regarding deployment of his vehicles within the 60 days.
- (vii) The bidder shall sign and stamp each and every page of the tender document in confirmation that all the conditions mentioned in the tender are agreed to the bidder.
- (viii) The bid will be treated as non-responsive if it is found that the rates quoted by the bidder are contrary to the Tender requirement.

(8) Following information shall be submitted with the online tender document.

- (i) Demand Draft of tender processing fee and earnest money along with online technical bid shall be submitted at Registry Department on 2nd floor on or before 30/03/2024 upto 18:00 hours.

- (ii) Complete detail about experience required under this tender and other as per Annexure A,C,D,E,F,G in hardcopy only.
 - (iii) Annexure 'B' shall compulsory be submitted online. Tender of those bidders shall be rejected whose price bids are not submitted in the format prescribed by the Corporation. It is compulsory to quote rates online.
 - (iv) The contractor, to whom work order is issued, shall submit the receipts of payments of all types of tax, insurance and certified copy of registration book for his vehicle at the concerned project of the GMDC. The vehicles shall be deputed at the concerned project thereafter.
- (9)** GMDC believes that all the conditions are understood properly and then only the tender is submitted and no complain in this regard shall be considered. It is understood that the bidder offers rates, in accordance with his financial and administrative capabilities.
- (10)** Detail hardcopies of documents are required to be enclosed. The hard copies of the documents shall be submitted in a sealed envelope along with the technical bid and this envelope should be superscripted prominently as "Hiring Service of Jeep/Utility for other than Kutch Zone projects of Gujarat Mineral Development Corporation Limited" and name, address should be mentioned at the left lower corner of the envelop.
- (11) Online tender document shall be rejected for the following reason:**
- (i) The bidder fails to submit the bid within the time limit prescribed by the GMDC than in that case the bid submitted by the bidder shall be rejected without assigning any reason thereof.
 - (ii) If during the tender process and after finalization of tender process, it is found that the bidder has failed to provide complete information than the bid submitted by the bidder shall be rejected.
 - (iii) The bidder is required to submit the tender copy with his stamp and signature. If the bidder fails to submit the copy of the tender with his signature and stamp than also the bid cast by the bidder shall be rejected without assigning any reasons thereof.
 - (iv) The bid of the bidder shall be rejected if the bidder has made conditional offers. Conditional Offers cannot be accepted on any count and the same shall be resulted into rejection of the bid submitted by the bidder.
 - (v) If the bidder fails to comply with the terms and conditions of the Tender than also the bid submitted by the bidder shall be liable to rejected by the GMDC.
 - (vi) If it is observed that the bidder has intentionally provided false information than in that case, the bid cast by the bidder shall be rejected.
 - (vii) Scanned copy of the draft of Tender Processing Fee and Earnest Money shall be uploaded along with the online tender document and shall be submitted

personally in the Registry Department on 2nd Floor on latest by 30/03/2024 at 18:00 hours, in case of failing to do so the bid of the bidder shall be rejected.

- (viii) If the bidder does not fulfill the eligibility criteria as mentioned above than in that case also the bid submitted by the bidder shall be rejected out rightly.
- (ix) The bidder is required to provide the information as desired by the GMDC.
- (x) The Bidder or its directors have not been blacklisted by any Government Organization. The Bidder will submit a declaration to this effect as per the format provided in Annexure - D of the Tender Document. If at any time such declaration is found false, the bid will be rejected or if the contract work is already awarded, it will be terminated forthwith without payment of any compensation and the EMD/SD will be forfeited.
- (xi) Failing to adhere any conditions of this Tender.

(12) Bid and other material

Rates for all the vehicles mentioned in online tender shall be quoted considering the manpower, maintenance, materials, diesel, logbook, and all taxes and other materials, other than Goods & Service Tax (GST) on vehicle hire charges. No escalation in the rates except diesel will be given to the contractor due to any reasons whatsoever in nature.

Note: If the Diesel price increases/decreases, the additional/deducted rate shall be calculated on the basis of 12 km/liter. The increase/decrease in diesel price shall be considered for the number of kilometers for which the vehicle is used. An example in this regard is as under:

For example: Per Jeep/per month kilometers fixed by the GMDC are 3000

Actual use of kilometers per Jeep/per month is 2400

Rate of diesel on the date of opening of technical bid is Rs. 50/liter

New rate of diesel is Rs. 52/liter

Difference of diesel price is Rs. 2/-

Calculation: If the Jeep runs on an average of 12 kilometers per liter, it requires 250-liter diesel for 3000 KM.

However, if it is used for 2400 kilometers then average consumption of diesel comes to 200 liters. Accordingly, after calculating the difference of Rs. 2/- per kilometers, the Corporation requires to make additional payment of Rs. 400. (This calculation shall be applicable for both the cases of increase or decrease).

(13) While submitting Online Tender

- (a) It is compulsory to quote project wise online price in the price bid in Annexure 'B'.
(price shall be quoted in the format prescribed by GMDC without mentioning any condition)
- (b) In case of any further information or clarification, General Manager (HR) - phone number 079-27913200 may be contacted.

(14) Opening of Online Price Bids

Only technically qualified bidder's Price Bid shall be opened online. The concerned bidder shall be informed separately through letter/SMS/e-mail regarding opening of price bid so that they can view the details at their own.

Grand Total of Rate quoted in column (6) of Annexure-B will be taken as the base rate for deciding the lowest bidder (L1) for all the projects. No part quantity offering within the project will be accepted. The rate quoted should in no case be the conditional and the offer must include all charges like Diesel cost, Driver, maintenance, road passing, RTO Tax, Insurance, logbook, other charges taxes / duties associated and other incidental expenses with running of the Jeep/Bolero/Utility except the toll taxes which would be reimbursed by GMDC on production of the original receipt. During the period of contract, if any new tax is imposed by Govt. the same shall be reimbursed by GMDC on submission of original receipt as a proof of depositing with the Govt. by the contractor.

(15) Payment of wages & Night stay allowances to the driver in case the vehicle is sent out of Project

It is compulsory for payment of wages should be paid through bank. In case the vehicle is sent out of project, the driver shall be paid Rs. 500/- per night allowance in case of night stay. Driver shall not be paid overtime by GMDC.

(16) Running of Vehicle and Its Maintenance

- (i) The contractor shall be responsible for carrying out required maintenance and to fit spare parts in the vehicle in order to run the vehicle in good condition.
- (ii) The contractor shall bear all the costs to run the vehicle such as fuel, oil, salary of drivers, bonus, maintenance and premium of third party insurance and other necessary expenses, etc.
- (iii) The contractor shall maintain required registers for mines safety/factory and follow all rules and shall bear the cost thereof as per law.
- (iv) The contractor shall pay all duties such as Goods & Service Tax (GST), road tax and all other tax for each vehicle and shall have accidental insurance policies for all the vehicles and shall produce details and receipts of payments of premiums thereof.

- (v) In case due to any of the reasons if the contractor fails to provide the vehicle for any number of hours / days in a month, one and half times rent for such number of hours/days shall be deducted from the bill of that month.
- (vi) In addition to clause 14 (v) ,in the event of breakdown/accident during the shift hours or the contractor withdraws back his vehicle due to any of the reasons; in such case the contractor at his own cost shall make alternate arrangements. Failing to do so, the GMDC shall make alternate arrangement itself on behalf of the contractor and cost thereof shall be recovered from the bill of the contractor. Making alternate arrangement becomes the primary responsibility of the contractor.
- (vii) It is necessary to have insurance policies for all the vehicles. In case of accident, the contractor shall be responsible for all types of compensation and shall also bear court/legal expenses arising out of the same.
- (viii) The contractor is under an obligation to adhere all the provisions and rules of Contract Labour and Provident Fund. Moreover, the Contractor shall have to adhere to the laws like Mines Act, Factories Act, Employees Provident Fund Act, Minimum Wages Act, Motor Vehicles Act, The Motor Transport Workers Act, 1961 Payment of Wages Act, Payment of Bonus Act, Employees Compensation Act, etc. The above list is not exhaustive. Further the contractor shall have to maintain all the required statutory registers and submit the returns before stipulated time. Any change and/or variation and/or introduction of new law shall be made applicable to the contractor.
- (ix) In case of damage to the property of the GMDC, injury or loss of life due to accident during the continuation of contract period, the contractor shall be liable for the total payment towards damages or compensation.
- (x) The contractor, getting work order, shall fix a board superscripting “On Duty GMDC)” (along with the logo of the GMDC) on the vehicle.
- (xi) The contractor shall take due care with regard to proper dressing of the driver while the driver is on duty. Further with regard to uniform of the driver, the contractor is under an obligation to follow the direction issued by the Statutory Authority.

(17) Maintenance of Log Book

Driver of each vehicle shall maintain records of kilometer readings and log book for the same shall be filled on day to day basis. Reading of start meter and end meter shall be noted in log book and the driver shall obtain signature of the officer authorized for the same on daily basis.

The concerned driver shall ensure that speedometer of vehicle is in working condition and shall get it repaired immediately in case of fault, if any, in the same and the officer authorized in this behalf shall be informed immediately. In case of non-working of speedometer, the number of kilometers certified by the Project Officer shall be accepted.

The place of parking shall be decided by the Contractor to park the vehicle after completion of the official duty. Payment of running vehicle from the place of parking to the place of duty shall not be paid, meaning that this cost shall be borne by the contractor.

(18) Running of Kilometers

In case the vehicles run more than the monthly kilometers prescribed, the payment for those additional kilometers shall be made every three months as per the rate quoted in the tender and on completion of three months the number of unused kilometers remained credit during these three months period shall be adjusted against use of such additional kilometers.

Total KM of all the vehicles allotted to project will be taken into consideration. Moreover, the said total KMs will be adjusted at the end of the three months. The excess KMs at the end of three months shall not be carry forward further for the purpose of adjustment.

(19) Providing additional vehicle

In case of need of additional vehicle by the GMDC during the currency of the contract, the contractor shall have to provide the additional vehicle in accordance with the agreed terms and conditions of the tender. If the contractor is not in a position to provide additional vehicle in time limit, the GMDC shall have powers to hire vehicle from other source/s.

(20) Security Deposit

20.1 Security Deposit is measure of liquidated damages sustained by GMDC for not performing the contract satisfactorily. Nothing herein above shall disentitle GMDC from claiming the damages sustained in the value over and above the Security Deposit.

20.2 The successful bidder shall submit security deposit of 5% of the total contract value excluding Goods & Service Tax (GST) at within 10 days from the date of issuance of LOI in any one of following form.

i. Demand Draft in favor of GMDC Limited Payable at Ahmedabad.

20.3 It shall be refunded to the Successful bidder, within a period of six months after satisfactory completion of the work and removal of equipment, tools tackles, campsite etc, and the due fulfillment of all the terms and conditions of the contract.

20.4 The successful bidder will also have to submit "NO DEMAND CERTIFICATE" along with the above-mentioned certificate.

20.5 The SD deposited by the Successful bidder may be forfeited if the successful bidder fails to adhere to fulfill the conditions of work order / agreement.

20.6 Security deposit shall not bear any interest under any circumstances.

20.7 GMDC will reserve the right to recover the charges or the liquidated damages from the Security Deposit in the following circumstances-

i. If the successful bidder or its employees causes any damage or destroy any property belonging to GMDC.

ii. The shortfall amount of all compensations, penalties, and other sums of money payable by the successful bidder or recoveries to be made under the terms of this contract which is due but not paid by the successful bidder in full, etc.

iii. Any other dues on account of statutory compliance.

(21) Goods & Service Tax

Goods & Service-Tax will be paid / adjusted / reimbursed to the contractor as per prevailing rates and rules as per G.S.T Act to the extent directly related to the services rendered by the contractor under the said contract subject to production of documentary proof and the contractor will mention the Goods & Service-Tax amount separately in the invoice / bill after considering the abatement, if any. Contractor has to provide it's GSTNo. before commencement of work.

(22) Payment of Bills

100% amount of the total bill shall be paid by the concerned Project Offices within 10 days from the submission of the bill. The payment shall be released through bank only. The contractor shall submit bills along with , Wage Register, Attendance Register, PF Challan-ECR Copy and all other statutory document in first week of each month at the concerned Project Offices. For the purpose of verification of kilometers, log book duly signed and stamped by the competent officer of GMDC shall be submitted along with the bill. Further, for payment of Goods & Service Tax the payment receipt of the Goods & Service Tax shall be submitted at the concerned Project Office and upon submission of the same, 100% amount paid towards Goods & Service Tax shall be reimbursed to the contractor by the concerned project office. It is obligatory that the contractor shall make payment of salary to his staff on or before 7th day of every month. The payment towards Salary of contractor's employee shall be released through bank only. Deductions of TDS (Income Tax) and other applicable taxes as per rules shall be made from the bill.

(23) Local Facilities and Services

- (a) The contractor shall make arrangement to bring diesel/oil/ diesel exhaust fluid ,etc from the nearby petrol pump at his own cost.
- (b) No other facility shall be provided by the GMDC. Contractor shall make all arrangement for residential, electricity, etc. at his own cost. However, GMDC may have its discretion to provide the facility subject to payment of rent and other levies and taxes as per norms.

(24) Termination of Contract

The GMDC reserves the right to terminate the contract at any time during the currency of contract for following reasons:

- (i) In case of violation of the terms & conditions of tender.
- (ii) The contractor fails to supply vehicles as per tender.
- (iii) In case of misconduct, indiscipline or breach of law in any way on part of any of the employees hired by the contractor

- (iv) In case the contractor fails to follow the statutory provisions
- (v) Due to unsatisfactory services and on receipt of frequent complaints

Upon termination of contract for aforementioned reasons and any other reasons attributable to contractor, the Security Deposit submitted by the contractor shall liable to be forfeited.

(25) NON FULFILMENT OF TERMS & CONDITIONAND TERMINATION OF THE CONTRACT

1. If the Contractor fails to carry out the work as per terms and conditions of the contract to the satisfaction of the GMDC, GMDC shall be entitled to forfeit the security deposit paid by the Contractor. This however, shall not absolve the Contractor from his obligation to fulfill the contract. In such event, the CORPORATION shall have a right to complete and / or to get the work completed at the cost & risk of the Contractor and the Contractor shall be responsible to pay such cost incurred by the GMDC to complete the work and / or to get the work completed.
2. Likewise, if the Contractor does not fulfill the terms and conditions of the contract and does not carry out the work up to the entire satisfaction of GMDC, GMDC has the right to forthwith terminate the contract at its sole discretion, without assigning any reason, Under such events, the GMDC shall be entitled to forfeit the security deposit paid by the Contractor and the GMDC shall have a right to complete the work and / or to get the work completed at the risk and cost of the Contractor.
3. For any reasons, if it is required, the GMDC reserves rights to cancel, terminate, amend and / or alter the contract and / or bifurcate and / or increase and/or reduce the contract work at any time without giving any notice to the Contractor and without incurring any responsibility.

(26) Recovery of outstanding amount of the GMDC

Any amount or levy from the contractor on completion of the contract period shall be recovered from the security deposit.

(27) Sub Contract

The contractor shall not sublet this contract to any other contractor. Subcontract is strictly prohibited.

(28) Jurisdiction

Matter relating to any dispute arising out of the present Tender & Subsequent of Contract shall be subject to exclusive jurisdiction of courts at Ahmedabad only.

(29) Arbitration

All questions, disputes, differences whatsoever which may at any time arises between the parties to this Tender and subsequent contract in connection with the contract or any matter arising out of or in relation thereto, shall be refereed to sole arbitrator as per the provision of Arbitrations and Conciliation Act. 1996 and the venue of the arbitration proceedings shall be at Ahmedabad only.

(30) FORCE MAJEURE

1. Force majeure is herein defined as any cause which is beyond the control of the contractor or the Corporation as the case may be which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affect the performance of the contract, such as:
 - i. Natural phenomena such as flood, draughts Cyclone, earthquake and epidemics, declaration of war.
 - ii. Acts of any government, including but not limited to war, declared or undeclared priorities, quantities, embargoes, providing either party shall within fifteen (15) days from the occurrence of such a cause notify the other in writing of such cases.
2. The contractor will advise, in the event of his having resort to this clause by a registered letter duly certified by the statutory authorities, the beginning and end of the cause of delay, within fifteen days of the occurrence and cessation of such Force Majeure condition. In the event of delay lasting over two months, if arising out of Force Majeure, the contract may be terminated at the discretion of the GMDC.
3. For delay arising out of Force Majeure, the contractor will not claim extension in completion date for a period exceeding the period of delay attributable to the causes of force Majeure and neither company nor he Contractor shall be liable to pay extra costs (like increase in rates, remobilization, advance, idle charges for labour and machinery etc.) provided it is mutually established that the Force Majeure conditions did actually exist.

If any of the Force Majeure conditions exists in the place of operation of the contractor even at the time of submission of bid he will categorically specify them in his bid and state whether they have been taken into consideration in their quotations.

4. The contractor of the GMDC shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/ or defined above. The date of completion will, subject to hereinafter provided, be extended by a reasonable time given.

(31) Prior Approval for Maintenance/Repairing

As the contract for the above vehicles is covered under the essential services, permission for carrying out repairing/maintenance shall be given for any of two days in a month with prior approval of the project authority. However, the contractor shall make his own arrangement to provide other vehicle during this period.

(32) Required Notice

Till the finalization of tender, the bidder shall visit the websites of the GMDC/n Procure website on daily basis and the bidder shall be responsible for the same.

(33) If any dispute arises about the interpretation of any condition, instruction the decision of the management of the GMDC shall be final.

(34) MD, GMDC is authorized to take suitable decision and action in case of requirement to amend/alter the contract conditions/quantities of the works/ extension of the contract Period/allotment of additional quantities of the works etc., if necessary, in the interest of GMDC.
