



**Volume Based Discount Scheme for All Lignite customers
(Captive & Non-Captive) for Bhavnagar Mine**

1. The scheme will be known as Volume Based Discount Scheme for Lignite customers (Captive & Non - Captive) and applicable to all the Lignite Lifting Customers.
2. The scheme will be applicable for Bhavnagar Mine only.
3. The scheme was effective from 1st November 2024. The same Discount scheme is extended for the **Q2 of FY25-26 i.e. from 1st July 2025 to 30th September 2025.**
4. Discount will be payable on quarterly (Jul to Sep-2025) basis on cumulative lifting of quantity after quarter. The discount will be paid by way of Rs. Per MT as per the actual lifting during the quarter for the qualifying customers as per criteria mentioned in table below:

Minimum Quarterly Booking Quantity	Minimum Quarterly Lifting Quantity	Discount in Rs/MT (For Lignite Quantity Lifted Quarterly)
15,000 MT*	12,000 MT (Considering 80% of 15,000 MT)	100
7,500 MT*	6,000 MT (Considering 80% of 7,500 MT)	50

** In case the Booking Quantity is less than 15,000 MT but the lifting is more than 12,000 MT then the customer will be eligible for the Rs.100 per MT discount on total quantity lifted.*

*** In case the Booking Quantity is less than 7,500 MT but the lifting is > 6,000 MT and <11,999 MT then the customer will be eligible for the Rs.50 per MT discount on total quantity lifted.*

**** However, if the minimum lifting is not attained for the qualifying quantity, then the customer will not be eligible for any discount irrespective of booking quantity.*

5. For the consideration of discount, the Lignite Quantity Lifted from Bhavnagar Mine (Incl. of all grades BA, BB, Bat, BBt, BAEI, BBEI etc.) shall be considered.
6. The amount will be paid to the customer in cash (Online Payment) or can also be utilized for taking mineral (here Lignite) and only after verifying the total quantity of Lignite lifted from Bhavnagar Mine during the quarter and will be paid to customer within 2 weeks of completion of quarter.
7. GMDC would be paying discount on the quantity of Lignite lifted in compliance with prevailing Income Tax and GST Provisions as applicable from time to time. The royalty would continue as levied as per prevailing norms.
