- 1) Basic Price is excluding of other applicable duties and taxes like royalty, DMF, NMEDT, GST, TCS etc.
- 2) Basic Price for non-captive customers displayed on GMDC website will be applicable to EOI bidders.
- 3) GMDC reserves the right to increase or decrease the basic price from time to time.
- 4) Incentive scheme (if any) applicable to non-captive customers will be applicable to EOI participants.
- 5) GMDC will deliver lignite on as is where is basis and there will be no price adjustment for quality variation.
- 6) GMDC will allocate the bid quantity proportionally over 5 months period, e.g., 5,000 MT per month for 25,000 MT.
- 7) EOI Participants will endeavor to lift the material on fairly evenly spread basis over 5 months period.
- 8) GMDC reserves the right to stop or proportionately reduce dispatches (under unforeseen circumstance only).
- 9) EMD will be returned upon completion of lifting minimum 80% of Bid quantity within 31/03/2026.
- 10) EMD will be forfeited if minimum 80% quantity is not lifted within 31/03/2026.
- 11) GMDC reserves the right to extend lifting period if dispatches are affected due to unforeseen reasons.
- 12) GMDC reserves the right to select or reject the EOI submission of any participant at its own discretion.
- 13) GMDC at its own discretion can increase the validity period for submission of EOI.
- 14) GMDC reserves the right to discontinue the dispatches without assigning any reason during the 5 months period
- 15) This EOI is for BA Grade (ROM Quality of Lignite) and the price mentioned above is for BA Grade Lignite.
- 16) GMDC reserves the right to scrap this EOI or make any modifications to this EOI proposal.
- 17) GMDC may offer BB Grade (sized Lignite 0 – 100 mm) upon availability and upon receiving interest at BB Grade Price
- 18) D.O booking for any particular month closes 4/5 days before the last day of the month.
- 19) GMDC may allot additional quantity (upon availability) to any participant upon receiving request from customer.
- 20) GMDC may offer additional quantity from its other mines (subject to availability) at the specified price for those mines.
- 21) Interested entities / bidders are requested to check GMDC website for regular updates.
- 22) GMDC guidelines and policy will be applicable (in general) to all participants for the execution of this EOI.
- 23) In case of any dispute, decision of MD GMDC will prevail unopposed.
- 24) GMDC may at its option, extend this scheme beyond 5 months for another 12 / 24 months on mutually agreed basis.
